SETTING UP OF JUTE FACTORIES IN BIHAR

- 825. SHRIMATI PRATIBHASINGH: Will the Minister of FOREIGN TRADE be pleased to state:
- (a) whether in view of the fact that Bihar is the largest producer of jute, the Indian Institute of Foreign Trade has recommended that two jute mills for producing carpet backings and packing materials be set up in that State; and
- (b) whether any decision in the matter has been taken by Government; if so, the details of the scheme?

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE (SHRI A.C. GEORGE): (a) Bihar is not the largest producer of jute. The Institute had suggested the establishment of a few jute mills in the jute growing districts of the State to increase the production of quality jute.

(b) The Bihar State Government have been requested to formulate suitable plans for establishment of a new jute mill in the State.

Besides this, the Government of Bihar have also been requested to give their consent for taking over the existing three jute mills—2 at Katihar and 1 at Muktapur under I.D.R. Act for their modernisation and improvement.

ENQUIRY IN TO BALARAMVARMA TEXTILE
MILLS, SHENCOTTAH

827. DR. K. MATHEW KURIAN: Will the Minister of FOREIGN TRADE be pleased to state:

- (a) whether the Committee appointed under the Chairmanship of Shi C. A. Subramaniam, to investigate into the affairs of the Balaramvarma Textile Mills, Shencottah, Tamil Nadu has submitted its report to Government; and
- (b) if so, what are its main recommendations and what decision Government have taken thereon?

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE (SHRI A.C. GEORGE): (a) Yes, Sir.

(b) The Committee has recommended that the management of the mill may be taken over by Government under section 18A of the Industries (Development & Regulation) Act. The Committee's recommendations are being considered.

RAILWAY TRACK FOR WEST COAST

828. SHRI VEERENDRA PATIL:

DR. K. NAGAPPA ALVA:

Will the Minister of RAILWAYS be pleased to state :

- (a) whether there is any proposal under Government's consideration to lay railway track on the West Coast; and
- (b) if so, what are the details in this regard?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MOHD. SHAFI QURESHI): (a) and (b) Engineering Reconnaissance and Traffic

Surveys for a new line from Apta to Mangalore in the West Coast region have been completed and the survey reports have recently been received in the Board's office.

A decision regarding the construction of this line will be taken after the survey reports are examined by the Board from all angles and the results thereof become known.

EXPORTS OF SANTINIKETAN BAGS AND PURSES

829. SHRI PRANAB KUMAR MUKHERJEE: Will the Minister of FOREIGN TRADE be plesed to state whether it is a fact that the manufacturers of famous Santiniketan bags and purses in West Bengal have not been able to cope with their export commitments of goods worth 150,000 U.S. Dollars by July this year; if so, the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE (SHRI A. C. GEORGE): Yes, Si.. The reasons are great demand in foreign markets for tanned sheepskin, which is used for the manufacture of Santiniketan leather bags and purses, and the exorbitant prices of this type of leather in India.

OVERBRIDGE AT KULTI STATION

830. DR. R. K. CHAKRABARTI: Will the Minister of RAILWAYS be pleased to state whether Government's attention has been drawn to the public demand for an overbridge at the crossing of the Kulti railway station in West Bengal; if so, the action so far taken in this regard?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MOHD. SHAFI QURESHI): Yes. As per extant procedure, the proposals for construction of road over/under bridges in replacement of existing busy level crossings are to be sponsored by the State Government/Road Authority who also give an undertaking to bear their share of the cost.
