(a) whether it is a fact that 21 types of teleprinters and attachments were manufactured by the Hindustan Teleprinters Limited, Madras, during the year 1971-72 ; and

(b) whether the shortage caused in production by the strike of July-August, 1970-71 has been fully met ? ]

संचार मन्त्री (श्री एच० एन० बहुगुणा) :

(क) कम्पनी ने वर्ष 1971-72 के दौरान 31 प्रकार के टेलीप्रिन्टरों और आनुषंगिक उपस्करों का उत्पादन किया था ।

(ख) भावी उत्पादन की योजना बनाते समय हड़ताल के कारण होने वाली कमी को ध्यान में रखा गया है । 1972-73 के लिये निर्धारित लक्ष्य में, पहली आई कमी की पूर्ति की आशा है ।

†[THE MINISTER OF COMMUNICATIONS (SHRI H. N. BAHUGUNA) : (a) The Company manufactured 31 varieties of : printers and ancillary equipment during the year 1971-72.

(b) The shortage caused due to strike has been taken into account while planning future production. The production target fixed for 1972-73 is expected to cover the earlier shortage. ]

### VACANCIES IN CLERICAL CADRE IN THE P AND T DEPARTMENT

\*382. DR. K. MATHEW KURIAN : Will the Minister of COMMUNICATIONS be pleased to state :

(a) the total number of vacancies in the clerical cadre in the Posts and Telegraphs Department as on 30th June, 1972, with break-up data for each State ;

(b) the number of Lower Grade Staff selected for promotion to fill the above vacancies ;

(c) whether Government are aware that in the Kerala Circle, many of the candidates from Lower Grade staff who were declared unsuccessful in the examination for promotion, had passed S. S. L. C. examination ; and

(d) whether it is also a fact that in the Kerala Circle, out of 38 vacancies reserved for scheduled castes and scheduled tribes candidates, only 3 have been selected notwithstanding the fact that there were several such candidates who were otherwise qualified ?

THE MINISTER OF COMMUNICATIONS (SHRI H. N. BAHUGUNA) : (a) to (c) The information is being collected.

(d) No Sir, 34 vacancies were reserved for Scheduled Castes and 27 for Scheduled Tribes. Only seven Scheduled Castes and one Scheduled Tribes candidate however, qualified appointment to the clerical grade.
