THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI MOHAN DHARIA) : (a) Yes, Sir The Government of India is aware of the news item published in the Hindustan Standard of the 9th June 1972.

However, no development plan for Sundarban Areas as reported in the news item, has so far been submitted by the Government of West Bengal to the Government of India.

**RECOGNITION OF Ex-I.N.A. PERSONNEL AS FREEDOM FIGHTERS**

Will the Minister of HOME AFFAIRS be pleased to state :

(a) whether the persons who served in Azad Hind Fauj are also eligible to the pension scheme for freedom fighters ; and

(b) if so, what are the details in this regard ?]

हैं जो 15 अगस्त, 1972 से शुरू हुई। भूतपूर्व आज़ाद हिन्द फौज के उन कर्मचारियों के परिवार भी पेंशन पाने के पात्र हैं जो अंग्रेज़ों से लड़ते हुए मारे गये।

[THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F. H. MOHSTN) : (a) and (h) All persons who served in the Azad Hind Fauj and had undergone six months' imprisonment in Mainland jails are eligible for grant of pension in the scheme which commenced from 15th August, 1972. Families of ex-INA personnel who died fighting the British will also be eligible for the grant of pension.]

#### CEMENT SHORTAGE IN WEST BENGAL

976. SHRI PRANAB KUMAR MUKHER-JEE : Will the Minister or INDUSTRIAL DEVELOPMENT be pleased to state :

(a) whether Government are aware of the fact that due to acute shortage of cement many developmental projects in the state of West Bengal have been stopped ; and

(b) if so, what measures Government have taken to increase the supply of cement to the State ?

THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRIAL DEVELOPMENT (PROF. SIDDHESHWAR PRASAD) : (a) and (b) The Eastern region of the country is traditionally deficit in the production of cement and its demand over supply within the zone has to be met by movement of cement from Western and Southern zone?. Normally during the period May to September every year, local shortages arise due to diversion of rail wagons for movement of foodgrains. During 1971, production of cement in the eastern region was also affected due to closure of Japla Cement Factory in Bihar. To overcome the inadequate supply of wagons and to improve the supply position, permission has been granted in appropriate cases to factories situated in distant areas to arrange supplies even, if necessary, over dearer routes at higher freights. More liberal movement by road is also permitted. Creation of dumps at Sambalpur, Rourkela and Tatanagar and transport of cement by rail-cum-road or road has been permitted. It has also been decided to re-imburse the producers up to 125% of the corresponding rail freight for transport of cement to

destinations beyond 100 kms. The Railways have also been requested to improve the availability of wagons to the various factories for the transport of cement. Supply of cement through coastal shipping at higher cost has also been permitted. As a result of these measures, the supply position of cement to West Bengal has considerably improved. As against 78,591 metric tonnes of cement despatched to West Bengal in January 1972, 87,129 metric tonnes of cement despatched in July, 1972. To augment the supplies further, the allotment of cement to West Bengal has been increased from 2.5 lakh tonnes in second quarter to 3.6 lakh tonnes for the current quarter of 1972. As a result of the efforts of the Central Government and the Government of Bihar, Japla Cement factory which remained closed during 1971 has restarted production with effect from 5th July, 1972 and it is likely to improve further the supply position to West Bengal. With the receipt of additional supplies of cement, now programmed, the deficiency partly felt for cement supplies by various projects under execution, will be overcome.

#### NEW INDUSTRIES IN TRIPURA

977. SHRI PRANAB KUMAR MUKHER-JEE : Will the Minister or INDUSTRIAL DEVELOPMENT be pleased to state what steps have so far been taken by Government for setting up new industries in Tripura ?

THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRIAL DEVELOPMENT (PROF. SIDDHESHWAR PRASAD) : The Industrial Development Bank of India, in association with other financial institutions such as IFC, ICICI, etc., have carried out an industrial survey of the State which has confirmed the potential for various industries such as jute, fruit canning, fertiliser, glass, plastic, etc. Follow-up action is being taken by the Committee of Direction of IDBI in consultation with the State Government and others. Apart from this a team from the DC (SSI) recently visited Assam and Tripura to explore the possibilities of setting up various industries in these States and has submitted a report suggesting the setting up of a few demand based and resources based industries there. Follow-up action on this report is being taken in consultation with Planning Commission and other organisations.
