- (d) what slrps are being taken by the Union Government to curb the activities of these agents?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F. H. MOHSIN): (a) to (d) Government has seen the news item. Government of Rajasthan has reported that the Chief Minister, in the course of his speech at Kanpur on July 30, 1972, referred to the possibility of attempts by hostile foreign elements and reaciionary forces within the country to disrupt communal harmony. Utmost vigilance is maintained to safeguard against the activities of foreign agents. It will be appreciated it would not be in the public interest to disclose the information in the possession of the Government or the details of what the Government does to counter such activities.

STATES' FIFTH FIVE YEAR PLAN

1050. DR. V. B. SINGH : SHRI CHAKRAPANI SHUKLA :

Will the Minister of PLANNING be pleased to state the steps that are being taken to involve the State Governments to formulate State plans as well as district plans, with the help of elected representatives as well as experts, well in time to integrate them in the Fifth Five. Year Plan?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI MOHAN DHARIA): In order to ensure that the strategy at the national level for the Fifth

Yuu Plan takes into account the potentials, prioritifs, capabilities and special endowments of different States, by a communication addressed by the Planning Commission on th< -'8th March, 1972, the State Governments have been requested to spell out their respective approaches to the Fifth Five Year Plan so as to reach the Planning Commission by the end of July 1972. The Planning Commission is already conducting an exercise on the formula-lion of its Approach Paper which will duly take into account the approaches indicated by the various States. Thereafter, in November 1972, it is expected by the Planning Commission that it will be possible to formulate and issue i lines to the Slates for the preparation of Draft Outlines of State Plans which should be ready by the 31st January, 1973 so that they can be fully taken into account in finalising the Draft Outline of the Fifth Five Year Plan by the due date.

to Qiistions

Since quite some time, and particularly since August 1971, the State Governments have been requested to set up State planning bodies and to strengthen the State planning machinery by the introduction of experts in various fields for associating with, and giving guidance to, the planning efforts of the State Governments. The State Governments have also been requested to set up Steering Groups and Task Forces under the Chairmanship of experts in the various disciplines, who should also be ex-officio members ol die State Planning Boards. Some of the State Governments have already set up apex planning bodies and others are contemplating to do so. The Planning Commission has decided to share the additional expenditure in the States on account of the setting up of apex planning bodies and of strengthening the State planning machinery. These arrengements will ensure that the approach of the State Govertim"nts to the Fifth Five Y- ar Plan and their Draft Outline-s of State Plan?, will be prepared under as careful and competent a guidance of experts as is available.

On the subject of formulation of District Plans, the Planning Commission has advised the State Governments since long and has also made available i:s services for the preparation itrict Plans in selected Districts on a pilot basis. VVotk is going on in most of the States in this behalf, and it is expected that these District Plans under the guidance of the Sia^e Planning Board.; and such other planning • eisations th-'t the respective State Govern-y set up, will be prepared well in time

for their being integrated into the Draft Outline of the State Fifth Five Year Plats mentioned earli'r.

In the communication sent from the Planning Commission to the State Governments bearing on the subject of formulation of the Fifth Five Year Plan, no specific suggestion has been made for associating elected representatives. The matter is left to the discretion of the State Governments. In the guidelines issued to the S.;ale Governments for the formulation of District Plans, suggestions have been made for the association therewith of local elected bodies like Panchayali Raj institutions.

THE MINISTER OF COMMUNICATIONS (SHRI H. N. BAHUGUNA): (a) Yes, Sir.

- (,a) whether Government are aware of the fact that Jail records of those freedom-fighters, who were in Fast Bengal Jails (Now Bangladesh) during British regime are no longer available:
- (b) whether the Government have received any representation for relaxing the conditions for proof of the period of imprisonment and also for the term "Dependants"; and
- (c) if so, whether Government propose to include the declared absconders on political ground during British regime and those who lost their lives or limbs during the country's freedom struggle without being imprisoned for Government pension?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F. H. MOHS1N; : (a) Yes, Sir.

- (b) Yes, Sir. Government have already decided that a certificate issued by an M. P. or Member of Slate Legislature or ex-M. P. or ex-Member of State Legislature who has been in jail with the applicant supported by an affidavit will be accepted as proof of imprisonment in plate of jail certificate. The term "Dependants" will also include father and widower of freedom fighter.
- (c) Persons who remained underground but did not suffer imprisonment would be eligible if they were (1) proclaimed offenders (2) for whom awards for arrest had been announced but were not arrested or (3) for whom detent i in orders were issued but not served.
