Besides, Tripura is eligible for all the three Incentive Schemes viz., Transport subsidy, 10 % Central Subsidy and Concessional Finance from Financial Institutions for industries to be set up there. Establishment of a jute mill in the State has been accepted in principle and the State Government has been requested to prepare a feasibility report. It is hoped that as a result of these measures some new industries will be set up in the State in the near future.

THE DEPUTY MINISTER IN THE INFORMATION AND MINISTRY OF BROADCASTING (SHRI DHARAM BIR SINHA): The present technical facilities available at the Udaipur Station of the A. I. R. do not permit transmission of programmes in the morning and afternoon hours in addition to the evening programme. A scheme to provide certain studio and other facilities during the current Plan is, however, under implementation. This Scheme when implemented, will enable the Station to start transmissions in the morning and afternoon, and also originate some programmes at Udaipur.
