FOREIGN WITH DEEP-SEA FISHING COLLABORATION

## 1276. SHRI S. KUMARAN: SHRI HAMID ALI SCHAM-NAD:

Will the Minister of AGRICUL-TURE be pleased to state:

- (a) whether any project report for deep-sea fishing with Foreign Collaboration has been submitted by Kerala Government: and
- (b) if so, what steps have been taken to accept it?

THE MINISTER OF STATE IN AGRICUL-OF THE MINISTRY ANNASAHEB (SHRI TURE SHINDE): (a) and (b) A project report for deep sea fishing with foreign collaboration was received from Government of Kerala in April, 1971, but the report did not indicate the name of the foreign collaborator.

A possibility which was taken for consideration in this connection was of bringing the project within the purview of Soviet aid. The policy relating to import of fishing vessels was under consideration. It was decided in March, 1972, that indigenous boatbuilding capacity should be fully utilised and that the balance of vessels should be imported from the U.S.S.R. to the extent of availability. An agreement for Cooperation in the field of Marine and Inland fisheries is being negotiated with the U.S.S.R. The feasibility of taking up the proposed proiect under the terms of the Agreement will be examined after the Agreement has been concluded.

- (a) whether it is a fact that the Central Government have sent bulk of the ration supply consisting of raw rice to the State of Kerala in spite of repeated requests for increase in the proportion of par boiled rice in the Central supplies because of the marked preference of the consumers in the State of Kerala:
- (b) whether the Government of India have considered to allot more par boiled rice to the State of Kerala so as to enable the State Government to increase the scale of rice ration to 200 grams per adult per day, keeping view of stepping up the foodgrains product tion substantially in the country; and
  - (c) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICUL-TURE (SHRI **ANNASAHEB** SHINDE): (a) to (c) The Government of India have always been endeavouring to meet Kerala's requirements of boiled rice to the maximum possible. The State Government have been allotted a substantial quantity of boiled rice out of the available stocks. The Kerala Government's requirements could not be met in full due to only limited quantities of the boiled being available in the Central stock. Possibilities are being explored to increase the production of par-boiled rice in the country.
