

**Request for naming the National Institute of Rural Development in  
Andhra Pradesh after Late Shri P.V. Narasimha Rao**

SHRIK. **Concern over the Closure of Lone Project of Tiger Reserve in Chhattisgarh**

SHRIMATI MOHSINA KIDWAI (Chhattisgarh): Mr. Deputy Chairman, Sir, in Chhattisgarh's Indravati National Park Tiger Reserve, no forest guard has entered for the last three years. Fifty-six revenue villages are surviving, virtually, outside the Government in a jungle where the People's War Group claims to run its own Government. Their presence has severely affected protection and conservation of wildlife. Not surprisingly, more than half of its tigers have been killed over the past five years. And the best timber in Bastar is fast being converted into cash by the heavily armed timber mafia.

The naxalite threat, notwithstanding, tiger census reports are filed every year. There are claims that 31 tigers were counted in the 2005 Census, the highest since the Park came under Project Tiger in 1984 with 38 tigers. Villagers are unanimous that they have not seen any forest staff inside the Park for years. The staff is afraid to tour and undertake protection works. Moreover, out of the sanctioned strength of 147,35 posts are lying vacant for a long time now.

Wild buffaloes, chitals, barking deer, nilgais and gaurs can be seen grazing in these areas while the Park has a sizeable population of tigers, leopards, striped hyenas, wolves and wild dogs. In view of such rare biodiversity, around 2,800 sq. kms. area of Indravati National Park was declared as Tiger Reserve in 1984. The Naxalites have reportedly set almost all the wireless stations on fire. Besides, they instigate the tribal population to encroach, cut timber illegally and poach.

Now the Union Ministry has reportedly decided, in principle, to close it down. I request the Government to save this Tiger Reserve and intervene in the matter by providing protection.
