- (a) whether Hindustan Steel and Neyveli Lignites are distributing their ferti lizer output through private sector 'large business house' trade channels instead of exploiting Public sector and cooperative channels;
- (b) what are the amounts of sales in last three years made to Shaw Wallace, Parry and Rail is by these two Public sector units; and
- (c) whether other Public Sector fertilizer manufacturers with their own marketing networks expressed interest in distributing HSL and Neyveli fertilizer?

THE MINISTER OF STEEL AND MINES (SHRI S. MOHAN KUMARA-

MANGALAM): (a) to (c) A state ment is placed on the Table of the House.

STATEMENT

(a) Neyveli Lignite Corporation is distributing Urea (the only fertiliser it produces) through private sector as well as through Government and Co-operative channels.

The Hindustan Steel Ltd. distribute their fertilizers through Cooperative, State Marketing agencies and private organisations. Distribution through large private business houses accounted for about 7% of their total sale of CAN and about 25% of the total sale of Ammonium Sulphate during 1971-72.

Later in June 1972, FCI approached the Corporation but by that time, the Neyveli Lignite Corporation had already finalised the distribution and entered into agreements.

Fertiliser Corporation of India had approached Hindustan Steel Ltd. recently for the distribution of fertilisers. Hindustan Steel Ltd., however, are continuing with the distribution system mentioned at (a) above as it has been working satisfactorily.
