The rates of wages paid to different categories of workmen are lower by 10 to 12% than the rates recommended by the Wage Board.

(b) Shri J.G. Kumaramangalam has been associated with the Neyveli Lignite Corporation from August, 1967, first as Managing Director and subsequently as Chairman-rwm-Managing Director. A number of problems are facing the Corporation including those of (i) acquisition and installation of additional mining machinery, fli) replacement of specialised mining machinery, (iii) a proposal to set up a super power station based on a second mine cut.
