CRASH PROGRAMME FOR EMPLOYMENT IN GOA

*408. SHRI BINDESHWARI PRA-SAD SINGH: Will the Minister of AGRICULTURE be pleased to state the progress made in the crash programme for employment in Goa?

THE MINISTER OF STATE IN THE MINISTRY OF **AGRTCUUFVRE** (PROF. SHER SINGH): The progress made in the implementation of Crash Scheme for Rural Employment in the Union Territory of Goa is as follows :-

1971-72.—Proposals for projects costing Rs. 12:51 lakhs were received from the Union Territory Administration. Out of these, administrative approval for Rs. 7:18 lakhs was given to the Administration. The remaining projects did not conform to the guidelines laid down by the Ministry of Agriculture and as such could not be approved. The Union Territory Administration, however, incurred an expenditure of Rs. 64,735 63 on the scheme up to 31-3-1972, generating about 17,000 mandays of employment.

1972-73.—The Union Territory Administration has issued orders for the implementation of the schemes which could not be completed during 1971-72. They have also sanctioned new works costing Rs. 3,97,042 to be undertaken in 3 blocks.
