1452. SHRI A. G. KTJLKARNI : Will the Minister of WORKS AND HOUSING be pleased to state :

(a) whether it is a fact that due to delay in the auction of shops in Pocket No. 2 Block No. C-2c Janakpuri, New Delhi the people living in this Pocket have to face great inconvenience for purchasing the articles of daily use ;

(b) if so, the time by when these shops would be auctioned;

(c) whether it is also a fact that the basic amenities like milk booth, dispensary, street lighting, post office, post office, public telephone and school

etc. are not provided in this Pocket; and

(d) if so, by when the D.D.A. propose to provide these amenities there ?

THE MINISTER OF STATE IN THE MINISTRY OF WORKS AND HOUSING (PROF. D. P. CHATTO-PADHYAYA) : (a) No, Sir. There is no delay in auction, the construction of shops has recently been carried out.

(b) In about one and a half months' time.

(c) and (d) The sites for amenities have already been provided by D.D.A. The D. D. A. only earmarks sites for milk booths, dispensary, post office, schools etc. and it is for the departments concerned to secure allotment of these sites and put up buildings thereon. Street lighting is done by Delhi Electricity Supply Undertaking. The D.D.A. has already deposited the necessary amount with the Delhi Electricity Supply Undertaking for energising the street lights.

THE MINISTER OF STATE IN THE MINISTRY OF WORKS AND HOUSING (PROF. D. P. CHATTO-PADHYAYA) : (a) Construction work on about 18262 flats is contemplated during the year 1972-73 out of which about 11,000 flats are likely to be completed during the year and the remaining during the next year.

(b) Rs. 13.70 crores.

(c) The total number of persons under the first registration scheme (i.e. November, 1969 to January, 1970) is 10812 and under the second registration scheme (i.e. November, 1971 to March, 1972) is 19110. The category-wise break up is as under :—
