(b) whether it is also a fact that the places which have been earmarked for roads and parks etc. are being used for dumping rubbish etc.; and

(c) if so, by when roads and parks etc. will be constructed at those places?]

निर्माण और आवास मंत्रालय में राज्य मंत्री (प्रो० देवी प्रसाद चट्टोपाध्याय) : (क) दिल्ली विन्यास प्राधिकरण ने दिल्ली नगर निगम में इस कालोनी को सफाई करने तथा कूड़ा हटाने का कार्य अपने हाथ में लेने का अनुरोध किया है।

(ख) और (ग) जी, नहीं। सिवाय दो सम्पर्क-मार्गों के, जो भूमि अर्जन को औपचारिकताओं के पूर्ण न होने के कारण पूरी नहीं की जा सकी, कालोनी की सभी सड़कें तथा पार्क योजना अनुसार पूरे कर दिये गये हैं।

(b) and (c) No, Sir. Except for two link roads which could not be completed for want of completion of formal-

ties of acquiring the land, all roads and parks in the colony have been completed as per plan.]
