PROMOTION OF TEMPORARY L D CS TO HIGHER GRADES

(a) whether it is a fact that temporary Lower Division Clerks were and are still being promoted to higher grades of Upper Division Clerks and Assistants, superseding the claims of permanent Lower Division Clerks,

(c) whether the promotion to higher grades of such of the Lower Division Clerks who could not pass the Typing Test as required under the statutory rules will be reviewed since in view of recent instructions from the Cabinet Secretariat (Department of Personnel) their confirmation and seniority is to be reckoned from the dates after 2nd October, 1971 only?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MOHD SHAFI QURESHI) (a) to (c) A statement is placed on the Table of the House.

STATEMENT

At present 248 employees in the Board's office hold their permanent lien in the grade of Lower Division Clerks. All these employees are working in officiating capacity in the higher grades of Upper Division Clerks etc. after having been found suitable to hold posts in the respective grades.

2 However, there are some 23 temporary Lower Division Clerks who were in turn for confirmation in that grade on the basis of the length of their service, but could not be so confirmed since they have failed to qualify in the prescribed type-writing test. Out of these 23 temporary Lower Division Clerks, 17 are working as Assistants, four as Upper Division Clerks and two in ex-cadre posts (one as Receptionist and the other on deputation to the Ministry of Defence).

3 The Department of Personnel vide their letter No 7/29/71-CS-II dated 2-3-72 have since decided that all Lower Division Clerks of the Central Secretariat Clerical Service who have completed 10 years or more of service as Lower Division Clerk on 22-10-71 (the date of the meeting of the Departmental Council) may be exempted from that date from passing the typing test for purpose of confirmation in Lower Division grade. Further in accordance with these orders, such Lower Division Clerks will also be eligible for confirmation in the Lower Division grade from a date not earlier than the date of exemption and be assigned seniority among permanent Lower Division Clerks in the order of their confirmation.
