however, expected that industries would avail of this concession during the year 1972-73.

The State Governments have been requested to give utmost priority to developing infra-structure facilities in the districts/areas declared as backward.

An informal Study Group has been set up in the Ministry of Industrial Development to review the working of the existing subsidy schemes and suggest measures for the speeding up of development of industries in backward areas.

IMPORT OF PRINTING AND WRITING PAPERS

(b) the details of the steps taken to manufacture such imported varieties of paper which are not produced indigenously?

THE MINISTER OF INDUSTRIAL DEVELOPMENT (SHRI MOINUL HAQUE CHOUDHURY): (a) and (b) A statement is laid on the Table of the House.

STATEMENT

- (a) There have been no imports of the common varieties of writing and printing papers during the last 3 years. However, some special varities of papers were imported. A statement showing the quantum of import of different kinds of papers during the last 3 years is enclosed. (See Annexure below).
- (b) Thirteen schemes have been approved by Government for the manufacture of coated, art and Chromo papers for a total annual capacity of 42,600 tonnes.

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI MOHAN DHARIA): (a) The approved Fourth Plan outlay of Madhya Pradesh State amounts to Rs. 393 crores.

(b) and (c) On a review of the resources available for financing the State Fourth Plan, it has been found that the outlay on the State's Plan could be increated to Rs. 435 croies. A final decision is, owever, yet to be taken both regarding the enhancement of the outlay and the vised sectoral allocation proposed by the ate Government.
