(b) whether the Government of India have examined the proposal ; and

(c) if so, what is their reaction thereto?

THE MINISTER OF STEEL AND MINES (SHRI S. MOHAN KUMARAMANGALAM) : (a) to (c) A statement is laid on the Table of the House

STATEMENT

(a) No, Sir. The State Government ha\e, however, furnished the Ministry of Steel and Mines with a copy of a Feasibility Report prepared for them by Messrs. Dastur & Co. for aji. integrated steel plant in Orissa. The Consultants have recommended the location of a plant at Nayagarh.

(b) This proposal will be examined along with other studies being made for the steel development programme.

(c) Does not arise, at this stage.

DR. R. K. CHAKRAB ARTI : So far as my information goes, that report has been submitted by the State Government regarding the steel plant. My first question to the lion. Minister is this : Can we expect a firm date regarding a decision in this respect ? And my second question in connection with part (e) is : If any other State Government submits any proposal for a new plant, will it be considered by the Central Government ?

SHRI S. MOHAN KUMARAMANGALAM : The House will appreciate that even the proposal from the Orissa Government is in respect of plants to be put up after the end of this decade or towards the end of this decade, that is to say, plants to come into operation in 1980, 1931, 1982 and so on, because they are the plants to be constructed after completing the of present construction the round Visakhapatnam, Vijaynagar, Salem, the expansion of Bhilai and the expansion of Bokaro up to 4 million tonnes. And naturally any proposal from any State Government will be given consideration. But ultimately it will be the duty of the Government of India to decide, on an overall assessment of the position, which is the best area where these plants should be put up.

SHRI PRANAB KUMAR MUKHERJEE : In view of the fact that most of the public sector steel projects are not utilising their full capacities of production, may I know from the Government whether they will lay emphasis on reaching the full production capacity in the existing plants instead of raising hopes of establishing new steel plants and making the establishment of steel plants a political issue? In this connection, may I further know whether the Government of India has any idea of expanding the Durgapur steel plant to reach a production target of 3 million tonnes a yean, as was promised by the Minister himself in January?

SHRI S. MOHAN KUMARAMANGA-LAM : The Gevernment does not look upon this question as choosing the alternative, that is to say, if we decide to improve production in the existing steel plants, we should pay no attention to the building of new steel plants. Government considers that both these things have to go hand in hand, and we are concentrating in both areas, namely, raising the present level of utilisation of the existing plants as well as construction of new plants. So far as the question of expansion of the Durgapur steel plant is concerned, the matter is being examined and as soon as the feasibility report is put up, the Government will take a final decision.

SHRI LOKANATH MISRA : Sir, the Orissa Government along with its memorandum to the Minister of Steel and Mines, has submitted a feasibility report prepared by Daslur and Company. Dastur and Company is the most dependable consultant so far as the Government of India is concerned and it gives a calculation of an conomy of 35 per cent or so in case this steel project is taken up in Nayagarh. In view of the economy of the project if it is situated in Nayagarh, what is the difficulty in the hon. Minister taking an immediate , decision in the matter? That would economise sleel production in the country to a great extmt.

SHRI S. MOHAN KUMARAMANGA-LAM : The House will appreciate that however dependable a consultant may be—and the honourable Member is entitled to have his own opinion about the dependability of the consultant concerned—ultimately it is for the Government, after examining the report and recommendations of the consultant, to come to a conclusion. We will naturally look into the. report that has been submitted by the Orissa Government prepared by the Dastur & Co. carefully before coming to a conclusion. Hurry in such matters does not always help.
