

Tin's necessitated additional mine openings and additional mining equipment for mechanised mining ;

(ii) In the case of Plants, the earlier estimates were based on preliminary process design, particularly in the case of Smelter and Refinery. With the completion of the detailed designing, additional equipment not included in the earlier estimates had to be provided for in order to meet the process requirements.

(iii) A part of the increase is also due to general escalation in the prices of equipment, material and services over the last 4 years ; and

(iv) The delay of about 2 years in the completion of the Project has also resulted in additional expenditure on supervision, etc.

SHRI K. C. PANDA : As per certain reports appearing in the national papers, copper mine has been traced out in Orissa. If it is so, I would like to know whether the Government is going to supplement the requirement of copper of this factory by some means or whether they will have another factory there.

SHRI S. MOHAN KUMARAMANGALAM: Mr. Chairman, I would like to have your ruling whether this matter arises out of this Question.

MR. CHAIRMAN : All right. Mr. Sundar Mani Patel.

SHRI SUNDAR MANI PATEL : Sir, I would like to know from the hon. Minister, "What was the first estimate for this project ; whether that estimate has been revised; and to what extent."

SHRI S. MOHAN KUMARAMANGALAM : So far as the estimate is concerned, there has been a revision in the original cost of the project from Rs. 93 crores—it was estimated in 1968—to Rs. 115 crores. The hon. Member will appreciate that this increase has arisen by and large because of the involved delays in the earlier execution of the programme.

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH) : (a) and (b) While the Soviet Union has put forward the idea of Asian Collective Security, no concrete proposals have so far been made by them in this regard. In our view, it is for countries in the reign to discuss various ideas on the subject and to evolve, in consultation with each other, ways and means to safeguard their independence and sovereignty and to strengthen co-operation amongst themselves in various fields.

SETTING UP OF REHABILITATION INDUSTRIES CORPORATION IN TAMIL NADU

THE MINISTER OF LABOUR AND REHABILITATION (SHRI R. K. KHADILKAR) : (a) No, Sir.

(b) Does not arise.

(c) The repatriates are rehabilitated in agriculture and plantation schemes. Some industrial schemes have also been sanctioned to provide employment to them. The families are also granted loans for business and housing. A Co-operative Society by the name of "Repatriates Co-operative Finance and Development Bank, Madras" has been set up with the main object of helping promotion of the rehabilitation of repatriates from Burma and Ceylon.
