THE MINISTTR OF LYTTRNAL AF FAIRS (SARDAR SWARAN SINGH) (a) Yes, Sir

STATEMENT

The special Fmissaries of the Pi s dent of Pakistan and the Prime Minister of India met at Murree and Rawalpinds from April 26 to 29, 1972. Shiri D.P. Dhai, Special Lmissary of the Prime Minister of India was assisted by Shiri A.S. Chib, Joint Secretary, Shiri P.L. Sinai, Director, Shiri S.P. Jagota, Director, Col. A.J. M. Hompi S. aff. Officer, Shiri J. N. Bhat, Press Officer, Shiri N. Dayal, Under Secretary and Shiri R.K. Kapur, Senior Research Officer of the Ministry of External Affairs, Government of India

Mr Aziz Alimed, Special Emissary of the President of Pakistan was assisted by Mr Rafi Raza Special Assistant to the President, Mi Ifitikhar Ali, Foreign Secretary, Ambassador Sajjad Hyder Mi Aftab Ahmad Khan Director General and Mr Abdul Sattar, Director General of the Ministry of Foreign Affairs, Government of Pakistan This was the first occasion on which representatives of India and Pakistan were alle to meet and communicate directly with each other on behalf of their Governments's ice the tragic divelopments of last year

The Special Emissaries held several sessions. These were nurked with cordiality and a readiness on both sides to appreciate each others' point of view.

Mi DP Dhar also called on His LacePency the President of Pakistan He conveyed to the President greetings of the Prime Minister of India and took the opportunity to thank him for the gracious hopitality occorded to him and members of his delegation

The Special I missaries have accomplished the task entrusted to them. They have settled the modalities for the forthcoming meeting between the President of Pakistan and the Prime Minister of India and have defined the subjects to be discussed by them. In this connection they considered several matters, including in particular those bearing on the establishment of durable peace in the subcontinent.

The two Emissaries wish to place on teco d their satisfaction that ground has been prepared for a meeting between the President of

Pakistan and the Prime Minister of India The meeting will be held towards the end of May or the beginning of June at New Delhi. A mutually convenient date will be announced in due course.

SHRI GULAM NABI UNIOO: Sir, the expected date, as has been stated, was the et d of May or the beginning of June. Now, after the hostile posture of Pakistan as we have observed in the Tithwal sector, and the intention of Pakistan. President to go abroad, may we take it that the date will be either end of June or beginning of July?

SARDAR SWARAN SINGH I will not try to make a guess about the dates. We are in touch with the Government of Pakistan, and a mutually convenient date is sought to be settled between the two countries. The ex-c date, I cannot at the moment indicate

DR. Z. A AHMAD Is there any move by Pokistan to get this date postponed?

SARDAR SWARAN SINGH: No, Sir.

SHRI KRISHAN KANT: The hon. Minister said there is no move by Pakistan to postpone the date because the first reports said it will be some day towards the end of May or the beginning of June But then, Mr Bliutto is going abroad. Does the Government of India find that some big powers are trying to influence Mr Bhutto not to have a mearingful dialogue with India, and does he connect the action of naval blockade in North Vietnam with Mr Bhutto dilly-dallying and trying to postpone the date by his going abroad to West Asian countries? Is big power politics playing a role to come in the way of the relations between India and Pakistan?

SARDAR SWARAN SINGH I would not like to confirm what the hon Member bas said.

SHRI KRISHAN KANT. The hon Minister may not confirm my vew, but may I know what is his view, of the matter?

SARDAR SWARAN SINGH You have not asked it.

SHRI KRISHAN KAN1. What is your view of the change or postponement of the meeting and other relevant developments?

SARDAR SWARAN SINGH I have not received any proposal from the Pakistan Government about the postponement of the date of the summit because no date has been fixed yet. The dates were being settled by mutual consultation. The question of postponement arises only if a date has been fixed.

DR Z \ \AHM\D \ But the time had been broadly fixed. The time is end of May or beginning of June

MR CHAIRMAN That was expected.

SARDAR SWARAN SINGH If hy mutual agreement any date is convenient to both the parties, that is something which should be treated as a matter which ordinarily happens. The convenience of two Heads of Governments or Heads of States has to be taken into consideration

SHRI CHANDRAMOULI JAGARLA-MUDI Due to the continuous violation of the ceasefire line by the Pakistan Government, do the Government of India have any doubt regarding the sincerity of the Pakistan Government about these talks?

SARDAR SWARAN SINGH. In international matters sincerity goes up to a point and each country has to see what is in the mutual interest. We believe that it will be in the mutual interest of both India and Pakistan to work for achieving durable peace and our off it, should continue to achieve that objective.

SHRI THILAI VILIALAN. From the joint statement I find that the Special Emissaries have defined the subjects to be discussed by them. In this connection they considered several matters including in particular those bearing on the establishment of durable peace in the sub-continent. May I know from the hon. Minister whether he can give the subjects decided to be discussed by both the Heads of States?

SARDAR SWARAN SINGH. No, Sir. I cannot give the list of subjects to be discussed.

SHRI M. K. MOHTA. May I ask the hon Minister if the Government of India have conveyed to Pakistan that one of the preconditions for a summit talk should be that any Indian territory which Pakistan has taken after the ceasefire should be returned to India?

SARDAR SWARAN SINGH No, Sir We have not made any such suggestion

SARDAR SWARAN SINGH I will request the hon Member not to ask from the Government the attitude that is to be taken in the course of the summit talks Summit talks cannot be conducted fruitfully if we were to make public statements on what we intend to do in the course of the summit talks

SHRI K CHANDRASEKHARAN May I know from the hon. Minister whether the Government of India, in the course of the talks that have already been conducted, suggested to the Government of Pakistan that at some stage the Bangla Desh Government would have to be associated in the course of further talks? May I also know whether the Government of Bangla Desh has been taken into confidence by the Government of India before finalising the subjects for the summit talks?

SARDAR SWARAN SINGH Sir, we have made it clear to the Pakistan Government that in any matter in which the Government of Bangla Desh is a necessary party, a settlement can be arrived at only by the association and agreement of the Government of Bangla Desh

About the second question, we have kept the Government of Bangla Desh fully informed of the nature of our talks with Pakistan

SHRI \ B RAJU There are newspaper reports that the head of the Bangla Desh Government and the head of Pakistan would meet somewhere in Furope How far is it true, and has the Government of India any information in this regard?

SARDAR SWARAN SINGH We have no information with regard to this. But we do have information to this effect that Sheikh Mujibur Rahman, Prime Minister of Bangla Dish, has said on several occasions that he has no intention to meet the head of the Government of Pakistan, unless Bangla Desh is recognised by Pakistan

SHRIIOKANATH MISRA In view of the two conflicting statements by two responsible persons in the External Affairs Ministry, may I know what the exact position is? Mr Dhar who as our emissary went over to Pakistan .

SHRI K P SUBRAMANIA MENON: "Went over" to Pakistan?

SHR1 LOKANA1H MISRA: return, like the Fxternal Affairs Minister of India, gave a Press statement saying that he had a most scintillating 65-minute talk with Mr. Rhutto and that he was completely satisfied about his sincerity and honesty But then it was contradict by Mi T N Kaul who said that he was most pessimietic about the outcome of the summit conference May I know what the hon Minister feels about the exact situation? In the meantime, the Tithwal incident from the Pakistan side has come Therefore, I would like to know the views of the External Affairs Minister as to what he feels about the situa ion In view of Mr DP Dhar's statement. who acted as the External Affairs Minister and Mr Γ N Kaul who equally vehemently made a subsequent public statement, what is his view regarding the matter and also may I know whether he feels that the statements made by the different officials of the External Affairs Ministry are desirable? Are the statements desirable in the public interest, to be made to the Press?

SARDAR SWARAN SINGH. In the first place, I would like to say that there was no conflict n the positions that emerged as a result of the statement made by Shri D P Dhar 13

and the statement which the hon. Member . . . (Interruptions) Please. Did I interfere when you were talking?

MR. CHAIRMAN: He is not interfering.

SARDAR SWARAN SINGH: There may be some difference on emphasis. But difference on emphasis is not of a nature which could be described as conflicting views. And in a situation like this, we should not speculate too much about the future. Here is a problem that we face: the problem is a difficult one. And we have passed through an armed conflict between our two countries. The objectives are clear. And our objective is to achieve durable peace. Whether in our effort we succeed, whether we are optimistic, over-optimistic, cautiously optimistic, less optimistic, is a matter of degree, about which there should not be much of speculation. And I would say that in a matter like this, our approach should be to do our utmost to achieve durable peace. There may be difficulties, and there are difficulties, and it would be wrong for anybody to under-estimate those difficulties. But that does not mean that we should give up the effort.

SHRI LOKANATH MISRA: Is it desirable to give a statement without referring the matter to you? You should have made the statement.

SARDAR SWARAN SINGH: Nothing is said unless I know it.

SHRI LOKANATH MISRA: Have you not seen these statements in the press?

SARDAR SWARAN SINGH: I have seen the statements in the press and even before the statements were made I knew what was going to be said. I take full responsibility for the statements.

SHRI LOKANATH MISRA: How are you responsible for this statement?

SARDAR SWARAN SINGH: He is an officer of my Ministry. And if an officer of my Ministry makes a statement I am responsible for it because I am responsible to this House, not the officer.

MR, CHAIRMAN: It is a suggestion.

SARDAR SWARAN SINGH: This is a suggestion. But there are practical difficulties in implementing that suggestion. For instance, I would very much like that I am not questioned about these things in this House. But I cannot avoid if hon. Members put questions. If an officer goes to foreign countries and press people. including the world press people, ask him questions, he has to make a statement. He cannot say that it is only the Foreign Minister of India that can make the statement. That will be the difficulty. And it is not likely to yield dividends in public relations. While dealing with the press that is the difficulty and practical difficulty which we have to face in an open society with free press and democratic institutions.

CHAIRMAN: Mr. Yadav, last MR. question.
