THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION AND POWER (SHRI BAIJNATH KURFEL) (a) Yes Sir An appraisal of power supply industry regionwise and Statewise upto the year 1974-75 has been made by the Seventh Annual Power Survey Committee

(b) The Survey indicates that the All India peak demand tor power of about 10.8 million KW at the end of 1970-71 will use to about 15.7 million KW by the end of 1973-74 and 17.7 million KW at the end of 1974-75. The generating capacity in the country at present is 17.2 million KW and will increase to about 20.4 million KW by the end of 1973-74. The margin of the generating capacity available over the peak loads would decrease towards the end of the Fourth Plan and then start increasing as the proposals for accelerated power development take effect.
