THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE (SHRI A C GEORGE) (a) to (c) The following demands have been received from the Rubber

(i) The absorption of an Accountant as Deputy Accounts Officer in the Rubber Board,

(ii) The retention on deputation of a Superintendent (Training) from the Office of the Accountant General Kerala and

(iii) The payment of bonus to the staff of the Rubber Board

While item at (i) above is pending as it is before the High Court of Kerala the other two items are being looked into

#### INDIA AS TEA EXPORTER

Will the Minister of FOREIGN TRADE be pleased to state

(a) how does India rank as an exporter of tea vis-a-vis other tea exporting countries,

(b) the steps taken by Government to popularise Indian tea abroad, and

(c) the quantity of tea likely to be exported during the current year?

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE (SHRI A C GFORGE) (a) India ranked first as an exporter of tea in the year 1971 having exported 212.6 million kgs against 201.3 million kgs exported by Ceylon, which ranked second as an exporter of tea

(b) (1) Promotional activities by the Tea Board's offices established in London New York Brussels Cairo and Sydney to create greater possibilities for export of Indiaa tea to various traditional and new markets

(2) Promotion of special packs of Indian tea in selected markets abroad with the co-operation of the local blenders/packers

(3) Advertisement through appropriate media of publicity in countries abroad

(4) Participation in Trade Fairs and exhibitions,

(5) Exchange visits of traders and tea experts to promote the interest of tea

(6) Setting up of a Tea Trading Corporation in the Public Sector for export of packeted and blended teas

(c) A quantity of 215 million kgs tea is estimated to be exported during 1972

#### SETTING UP OF FACTORIES FOR MANUFACTURING SYNTHETIC RUBBER

(a) whether there is any proposal under Government's consideration to set up factories for manufacturing synthetic rubber, and

(b) if so the names of the places where the factories will be set up and the expenditure likely to be incurred thereon ?

THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI DALBIR SINGH) (a) and (b) A unit to manufacture 20,000 tonnes of stereo Specific Polybutadiene Rubber is proposed to be set up in the public sector as a down-stream unit of the Gujarat Clefins Project at Baroda. The estimated capital outlay for this project is Rs 13.50 crores including a foreign exchange component of Rs 3.43 crores.

#### LOCATION OF SUB-SEA OIL

279 SHRI N. G. GORAY Will the Minister of PETROLEUM AND CHEMICALS be pleased to state

(a) what progress has been made in locating the sub-sea oil in Aliabet and Bombay high seas

(b) whether any contract has been concluded with any foreign firm in this regard, and

(c) if so by what time drilling operations are likely to start ?

THE MINISTER OF LAW AND JUSTICE AND PETROLEUM AND CHEMICALS (SHRI H. R. GOKHALE) (a) to (c) As far as drilling in shallow waters off Aliabet islands is concerned the first offshore well in the Aliabet West structure was spudded in on 19.3.70 and there was an oil show a year later. The results of production testing of the Well showed, however, that the oil find in this well was not of "commercial" importance. Drilling of a second well, this time in Aliabet-East structure, is presently under consideration.

As for Bombay-High area various preparatory steps for commencing drilling in that area are already in progress. The self-propelled, mobile offshore platform is under construction in Japan and is expected to arrive in India in November, 1972.

In connection with the work of drilling in Bombay-High area, a contract with M/s Mitsubishi Shoji Kaisha Ltd of Japan was concluded on 25.2.71 for construction and supply of the mobile offshore drilling platform. A contract was also concluded with M/s Offshore International S. A. for providing the services of certain experts for conducting the drilling operations along with Indian personnel for a

period of one year from the start of drilling, and for training of the Indian personnel in this regard. Drilling in the Bombay-High area is likely to commence soon after the Mobile Platform arrives in India in November, 1972.
