(b) Foreign exchange allocations are not made State-wise. The foreign exchange requirements of industrial and commercial units in different States are met in terms of the annual Import Policy which applies equally to similar units all over the country.

RECOGNITION OF LIC EMPLOYEES' ASSOCIATION

*206. SHRI K. CHANDRASEKHARAN : Will the Minister of FINANCE be pleased to state :

(a) Whether it is a fact that the Higher Grade Employees' Association of the Life Insurance Corporation has not been granted recognition; if so, the reasons therefor, and

(b) whether any other LIC employees' and agents' unions/associations have been granted recognition, if so, the details in this regard ?

THE MINISTER OF FINANCE (SHRI Y. B. CHAVAN) : (a) and (b) The "Code of Discipline", under which recognition is accorded, applies only to employees and not to agents. At present, there is no recognised union of Class III and Class IV employees of the LIC, but the question of recognising one in terms of the Code is under consideration.
