TAKING OVER OF NATIONAL SAMPLE SURVEY SECTOR

375. SHRI K. B. CHETTRI :

Will the PRIME MINISTER be pleased to state the reasons for the delay in taking over the National Sample Survey Sector of the Indian Statistical Institute by Government ?

THE PRIME MINISTER (SHRIMATI INDIRA GANDHI) : The work of National Sample Survey hitherto done by the Indian Statistical Institute, Calcutta is to be taken over by the National Sample Survey Organisation recently set up by Government in the Department of Statistics. The employees of the Institute engaged on National Sample Survey work and some employees engaged on common services are to be absorbed in Government service and appointed to posts in the National

Sample Survey Organisation on such terms as to ensure that there is no deterioration in the conditions of their service. The terms and conditions which would govern absorption of such employees were finalised after detailed discussions with the representatives of Indian Statistical Institute Council and Indian Statistical Institute Workers Organisation at a series of meetings held between the 29th June 1970 and 25th October 1971. A Government Resolution setting out these terms and conditions was issued on 17th January 1972. As a result of further discussions with these representatives regarding some points taken up by the Indian Statistical Institute Workers' Organisation, the Government Resolution has been amended on 30th April, 1972. It is expected that the National Sample Survey work being done in the Institute will be taken over by Government very soon along with the employees of the Institute engaged on such work and some of the common service employees.

EXPANSION OF PHILIPS INDIA

376. SHRI PRANAB KUMAR MUKHERJEE : Will the PRIME MINISTER be pleased to state :

(a) whether it is a fact that Philips India has submitted to Government a comprehensive plan for its expansion ; and

(b) if so, what are the salient points of the scheme and the reaction of Government thereto ?

THE MINISTER OF ELECTRONICS (SHRI K. C. PANT) : (a) and (b) M/s. Philips had, some time back, submitted a list of items in which they proposed to start new and or expand their manufacturing activity. This was in response to a Government Communication asking them to give a comprehensive plan of their future activity over the next 5 to 7 years with simultaneous reduction of their present foreign equity of 69.2%. What was submitted was just a list of items and not a comprehensive plan indicating investments, quantities, costs, technologies etc. They have therefore, been asked to submit such a comprehensive plan after which the whole issue will be examined. A technical committee consisting of representatives of Department of Electronics and Department of Industrial Development has been appointed to go into this whole question with M/s. Philips.
