SUPPLY OF WHEAT AND OTHER FOOD-GRAINS TO BANGLADESH

- 291. SHRI J. S. TILAK: Will the Minister of EXTERNAL AFFAIRS be pleased to state:
- (a) what is the total quantity of wheat supplied to the Government of Bangladesh;
- (b) what are the terms and conditions of the supplies made; and
- (c) what is the quantity of other foodgrains supplied to Bangladesh by our Government since 25th May, 1971 and the cost and the terms and conditions of such supplies?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH): (a) 650,000 tonnes of wheat are being supplied to the Government of Bangladesh.

- (b) All supplies are being made free of cost.
- (c) 100,000 tonnes of rice have been supplied, free of cost, since February, 1972. The question of making supplies before that date did not arise.

- (b) The award or the 19th Industrial Tribunal that May Day should be an additional paid holiday for the employees
