introduction of 12 car trains on the main line suburban section of Bombay Division

- (b) Remodelling of Bombay VT mainline and suburban station for dealing with longer trains, and provision of another passenger terminal in Pare)/ Dadar
- (c) Requirement of additional facilities in the existing Kurla shed and the proposed Kalva Car shed in Bombay area.

Western Railway

- (i) Double line section between Churchgate and Grant Road is being quadrupled.
- (ii) Provision of additional substations at Churchgate Matunga Road, Goregaon, Vile Parle and Virar. Besides!, the existing sub-station capacity is being augmented at Bassein Road and Grant Road. Additional sub-stations at Mahalaxmi, Borivli, Bhayandar and Nallasopara being proposed through future Works Programmes,
- (iii) Additional facilities are being provided for maintenance, repair and overhaul of rolling stock, substation enquipment and the supply network.
- (b) The cost of the above proposals would be about Rs. 16.19 crores on the Central Railway, and Rs. 26 65 crores on the Western Railway. This does not include the investment that may be necessary as and when the 12 car rake scheme may be introduced.
- (c) Apart from increasing the capacity due to replacement of old coaches with the new coaches having higher carrying capacity additional services are also proposed to be run progressively with the receipt of additional EMU coaches and *on* completion *of* various works mentioned above. Since 1-4-1970, 53 and 40 additional suburban trains have been introduced on the Western and Central Railways respectively.

EXPORT EARNINGS BY IMPPA

- 450. SHRI A. G. KULKARNr : Will the Minister of FOREIGN TRADE be pleasetf to state :
- (a) the export earnings by Indian Motion Pictures Producers' Association during 1970-71 and 1971-72;
- (b) the names of firms to whom advances had been made during the years 1969-70,1970-71 and 1971-72 for production of films; and
- (c) whether attention of Government has been invited to press reports that large amounts had been advanced to fictitious producers of films who had not made any exports?

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE (SHRI A. C. GEORGE): (a) Information is not available as statistics regarding export of films is maintained for a country as a whole and not by individual firm or by Associations.

- (b) The Indian Motion Pictures Producers Association Bombay is a private organisation and the Government has no control over its finances or admistration. As such information is not available. However, Indian Motion Pictures Export Corpn. which is subsidiary of the State Trading Corpn., are giving advances to the producers for production of films. A slatement giving particulars of such advances is attached.
- (c) The Indian Motion Pictures Export Corporation advance loans to the producerj against the overseas right of the Pictures on commission basis and as such the question of giving advance to the fictitious producer! of films does not arise.
