and it is, therefore, not possible to evaluate its effects on India's foreign trade with the various countries.

KRISHNA-GODAVARI WATER DISPUTE

- 515. MISS SAROJ PURUSHOTTAM KHAPARDE: Will the Minister of IRRI GATION AND POWER be pleased to state:
- (a) whether Government have made any fresh efforts to resolve the Krishna-Boda-vari water dispute; and
- (b) if so, the nature of the efforts made and the results achieved?

THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION AND POWER (SHRI BAIJ NATH KUREEL): (*)*and (b) The water disputes relating to the Krishna and Godavari rivers which could not be settled by negotiations amongst the States were referred to the Krishna and Godavari Water Disputes Tribunals on 10th April, 1969. The adjudication proceedings of the Tribunals are in progress.

OVER-BRIDGES ON RAILWAY CROSSINGS

- 516. MISS SAROJ PURUSHOTTAM KHAPARDE: Will the Minister of RAILWAYS be pleased to state:
- (a) whether there has been persistent demand from the public for constructing overbridges on the railway crossings in the city of Nagpur; and
- (b) if so, what action Government have taken in the matter?
- THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MOHD. SHAFI QURESHI): (aj Yes.
- (b) The proposals for construction of road over/under bridges in replacement of existing busy level crossings are to be sponsored by the State Government/Road Authority together with an undertaking to bear their share of cost. The Government of Maharashtra have not sponsored any finn proposal for construction of road over-bridges

on the railway crossings in the city of Nagpur.

NAGPUR SUPER THERMAL POWER STATION

- 517. MISS SAROJ PURUSHOTTAM KHAPARDE : Will the Minister of IRRI GATION AND POWER be pleased to state :
- (a) whether it is a fact that the work of the Nagpur Super Thermal Power Station (Koradi) in Maharashtra is going slow for nonavailability of required machinery in the country;
- (b) if so, whether any orders have been placed outside India; and
- (b) the time by when the work of the power station is likely to be completed?

THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION AND POWER (SHRI BAIJ NATH KUREEL): (a) No, Sir.

- (b) Orders for the turbo generating sets of 120 MW each and some steel have been placed in Poland.
- (c) The first generating unit is expected to be commissioned in October, 1973, followed by the 2nd, 3rd and 4th generating units at short intervals thereafter.

SLOW PROGRESS OF IRRIGATION SCHEMES IN VIDARBHA

- 518. MISS SAROJ PURUSHOTTAM KHAPARDE: Will the Minister of IRRIGATION AND POWER be pleased to state:
- (a) whether it is fact that some of the irrigation schemes in Vidarbha (Maharashtra) which were included in the Second Five Year Plan are still incomplete;
- (b) if so, the' names of such schemes; and
- (c) the reasons for the delay and the slow pace of execution?"

THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION AND POWER (SHRI BAIJ NATH KUREEL): (a) and (b) The Government of Maharashtra have reported that work on the Bagh, Itiadoh, Katepurna and Dina Nadi projects, included in the Second Plan for Vjdarbha region is still in hand

(c) The reasons have been indicated as follows:

Bagh Project—Inter-State aspects on submergence in Madhya Pradesh had to be settled and the project features modified. As such, much progress could not be done on the project till 1965. The project is now expected to he completed by June 1974.

Itiadoh Project—Difficult foundation condition required extensive investigations and model tests and foundation treatment. The dam has been since competed and the other works are expected to be completed by June 1974.

Kaupurna project—Non-availability of funds specially during the initial years, deep seated rock foundations needing substantial explorations and study of alternatives, poor response from contractors, labour trouble and non-availability of suitable construction materials.

, *Dina Nadi Project*—Non-availability of suitable foundations involved substantial explorations and investigations and limited funds which could be provided for the project.
