THE MINISTER OF EXTERNAL AF-FAIRS (SARDAR SWARAN SINGH): (a) and (b) Between May 13 to December 10, 1971, Prime Minister addressed communications to Heads of Govt, of a large number of countries including, of course, those in West Asia and North Africa with the object of keeping them informed on the evolution of the grave situation which developed as a result of the military action by the Pakistani military junta on March 25, 1971 and thereafter. Replies to these communications were received from time to time either directly or through diplomatic channels. The honourable Member wil appreciate that it is not customary to disclose these communications without mutual consent of the parties concerned. However, it may be stated that a reply to Prime Minister's communication of December 5, 1971 from one of the countries in North Africa was of a kind and character which contained an obviously distorted interpretation of events.

#### PLATINUM DEPOSITS NEAR NAGPUR

On receipt of this report, the Geological Survey of India undertook geological studies of the area and collected samples to test incidence of platinum in the rocks. The data so far available from these samples indicate only traces of platinum, which are irregularly and sparingly disseminated in the rocks. Further work by the Geological Survey of India is in progress. It will be too premature to comment on its economic viability.
