### ORAL ANSWERS TO QUESTIONS

#### JOINT VENTURES WITH YUGOSLAVIA

\*436. SHRI M. K. MOHTA : Will the  
Minister of FOREIGN TRADE be pleased to  
state :

(a) whether Government propose to set  
up joint ventures in third countries in colla-  
boration with Yugoslavia ; and

(b) whether the arrangements have been  
finalised in this regard and if so, the details  
thereof ?

THE MINISTER OF FOREIGN TRADE  
(SHRI L. N. MISHRA) : (a) and (b).  
Governments of India and Yugoslavia have  
agreed in principle to encourage co-operation  
among parties of the two countries to estab-  
lish joint venture has been established.

SHRI M. K. MOHTA : Sir, may I ask the  
honourable Minister if any details about the  
question of collaboration between Indian  
party and any Yugoslavian party have been  
decided upon in principle between the two  
Governments, particularly in respect of  
capital goods and also in respect of employ-  
ment in third countries of Indian engineers  
and technicians ?

SHRI L. N. MISHRA : No, Sir.

SHRI M. K. MOHTA : Sir, may I ask the  
honourable Minister if any Indian private  
firms have indicated to the Government their  
desire to set up any such projects in the third  
countries and if any such indication has been  
received by the Government, the name of the  
party and the particulars of the project ?

SHRI L. N. MISHRA : To my know-  
ledge no party has come forward to set  
up

such joint ventures, that is, by Indian parties  
in Yugoslavia and as regards any project in  
the third countries, to our knowledge, there is  
none.

श्री ओउम् प्रकाश त्यागी : अध्यक्ष महोदय,  
मैं यह जानना चाहता हूँ कि क्या सरकार वर्णित

अनुभव करती है और क्या प्रश्न में सरकार ने

किया है ? और यदि हाँ तो किन-किन देशों में  
आपने इस प्रकार के संयुक्त उपक्रम स्थापित  
किये और उसका क्या परिणाम निकला है ?

श्री एल० एन० मिश्र : यह सत्य है, यह  
हमारी धारणा है और संकल्प भी है कि दूसरे  
देश के साथ हम लोग इस चीज को करें और  
अभी तक करीब-करीब 135 ऐसी इंडस्ट्रियल  
इंटरप्राइजेज हैं जिसमें हमने माना है कि दो  
देश को करना चाहिए, उसमें से 30 तो  
उत्पादन में चले गये हैं और 66 जो हैं वह  
वैरियस स्टेज में हैं, बन रहे हैं, और 39 को  
किसी कारण से छोड़ दिया। और हमें डिबिडेंड  
भी आया है, 31 मार्च, 1972 तक 108 लाख  
में से करीब 93.4 लाख हमारे पास में  
आया है। जहाँ तक देशों का सवाल है  
यह लम्बी फेहरिस्त है। माननीय सदस्य चाहेंगे  
तो टेबिल पर रख दूंगा। बहुत देश हैं, 35 देश  
हैं जहाँ पर कि यह है।

श्री ओउम् प्रकाश त्यागी : सूची आप टेबिल  
पर रख दीजिएगा ताकि जानकारी प्राप्त हो  
सके कि कौन देश हैं।

श्री एल० एन० मिश्र : इसको पढ़ना  
होगा।

श्री ओउम् प्रकाश त्यागी : टेबिल पर रख  
दीजिये।

श्री एल० एन० मिश्र : हाँ, मैं रख दूंगा।

SHRI HARSH DEO MALAVIYA : Sir, is  
it the policy of the Government of India to  
include private capital of India in such joint  
ventures ?

SHRI L. N. MISHRA : Sir, they are mostly private capital only.

SHRI N. G. GORAY : Sir, these joint ventures are likely either to add to our prestige, or if they do not function well, India's name will suffer. In view of the fact that some of the joint ventures have not earned a good name for India—for instance, the joint venture in Addis Ababa—I would like to know what special steps the Government is taking to see that only the right type of people are encouraged to enter into such collaborations.

SHRI L. N. MISHRA : Sir, this is the question which has been agitating our mind. There have been some complaints from Ethiopia where one textile mill partly owned by an Indian company did something which they should not have done and perhaps some of the employees of the company were also convicted by the High Court of Ethiopia. After that, Sir, we decided to have one performance Cell and also ask our Commercial Commissioners in different Embassies and Missionaries to look after the performance of these joint ventures and we are contemplating to have a special cell in our Ministry to look after the performance of these units. But I must say, Sir, that on the whole they have done well. There have been one or two cases of complaint, and, of course, it will not be fair to run down the joint ventures with other countries in a general way.

SHRI N. G. GORAY : Have you already set up a special cell ? Or are you contemplating to set up a cell ?

SHRI L. N. MISHRA : I said that I am setting up a cell, apart from asking our Embassies in different countries, to look after their performance.

#### MANUFACTURE OF POLYURETHANE FOAM

CHEMICALS be pleased to state :

(a) whether the Central Government have received a proposal from the Government of Orissa for the manufacture of polyurethane foam ; and

(b) if so, the reaction of the Government of India thereto ?

THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI DALBIR SINGH) : (a) Yes, Sir.

(b) Several applications for manufacture of Polyurethane Foam received from the small scale sector are under consideration.

SHRI CHANDRAMOULI JAGARLAMUDI : Sir, is there any proposal from any other States to set up Polyurethane plants ?

SHRI H. R. GOKHALE : Sir, so far this production is concerned, there is a proposal from Orissa. From other States there has been no such proposal. But even if there were proposals, the policy would be uniform for all the States, namely, the idea is not to encourage large-scale production of this item.

SHRI CHANDRAMOULI JAGARLAMUDI : Is the Government of India aware of the shortage of polythene granule, which is due to the fact that two leading manufacturers, M/s. I. C. I. Ltd., and M/s. Union Carbide Ltd. are using most of their production of granules in the manufacturing of films ? If so, will the Government of India place any restriction on these two leading manufacturers ?

SHRI H. R. GOKHALE : The shortage can be met by allowing more units in the small scale sector, for which units have already been sanctioned in the small scale sector. More applications from the small scale sector are being received. There are two inhibitions. This is not a item which can be said to be such an essential item that without any restriction we will allow the import for the production of this item. Our policy is to encourage the development of this industry in the small scale sector.

SHRI SUNDAR MANI PATEL : I would like to know from the hon. Minister whether Messrs. Utkal Foam of Orissa..

MR. CHAIRMAN : Please speak a little louder.
