The information as now required by the Hon'ble Member would, however, take a very long time to collect and the actual results would perhaps not be commensurate with the labour involved.

**TAKE OVER OF THE HINDI PRIMARY SCHOOL AT FARAKKA BY THE FARAKKA BARRAGE PROJECT AUTHORITY**

767. SHRI SANAT KUMAR RAHA: Will the Minister of IRRIGATION AND POWER be pleased to state whether it is a fact that the Farakka Barrage Projects Authority proposes to take over the Hindi Primary School at Farakka which is now run by the management of the National Projects Construction Corporation ?

THE DEPUTY MINISTER OF IRRIGATION AND POWER (SHRI BAIJ NATH KUREEL) : The National Projects Construction Corporation has suggested that Hindi Primary School under their management at Farakka may be taken over by the Project Authorities. No decision has so far been taken on this suggestion.

**EXPORT OF COFFEE**

Will the Minister of FOREIGN TRADE be pleased to state whether in view of the increase in coffee production during 1970-71, Government have considered the question of exporting surplus stocks of coffee to the U. S. S. R., Poland and other non-quota countries, by direct deals through the Coffee Board ; if so, the decision taken in the matter ?

THE DEPUTY MINISTER OF FOREIGN TRADE (SHRI A. C. GEORGE): In view of the bumper coffee crop of 1970-71, negotiations were conducted for direct sale of coffee by Coffee Board to U. S. S. R. and as a result 3,000 tonnes were exported directly to that country. However, the question of similar direct deals with Poland and other non-quota countries out of 1970-71 crop has not been considered.
