

be tackled ? The hon. Minister sha said that on the date of the demonstration the Prime Minister was out of town but I believe the Minister of Finance was not in the Andamans nor in Satara. I should like to know whether the Minister of Finance cared to find out from the demonstrators as to what exactly they wanted in order that the Finance Ministry could take certain steps.

**SHRI K. R. GANESH :** What was your first question ? The second question I have got.

**SHRI BHUPESH GUPTA :** The only thing I have asked is whether you have considered the advisability of taking up the matter with the Pay Commission that the whole thing should be expedited in the interest of public policy in which the Government is interested.

**SHRI K. R. GANESH :** I have already answered many times in this House and the other House that the anxiety that has been expressed by the employees has been communicated to the Pay Commission. This matter was already raised in the Joint Staff Committee where it was discussed and the opinions expressed by the employees organisations there have also been communicated to the Pay Commission.

As far as the second part of the question is concerned, the *dharna* was not at my house or at the Finance Minister's house but at the Prime Minister's house. As I said, the main point as far as the *dharna* was concerned,—that the Pay Commission should submit its Report by June of this year—I have already informed that the Pay Commission has said that it will not be possible for it to give a firm date.

**SHRI VEERENDRA PATIL :** May I know whether the State Chief Ministers and Finance Ministers have repeatedly been representing to the Government of India to take them also into confidence before taking a decision with regard to increase of Pay scales and D. A. of the Central employees ? If so, may I know whether the Government of India proposes to take the State Chief ministers into confidence before taking a decision on the Pay Commission's Report ?

**SHRI K. R. GANESH :** The Pay Commission itself is going to consult the State Governments and discuss with them.

#### IMPROVEMENT OF TOURIST FACILITIES IN BIHAR

\*470. **SHRI DHARAM CHAND JAIN :** Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state the steps proposed to be taken by the Central Government for improving tourist facilities in Bihar ?

**THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH) :** The Fourth Plan contains a provision of Rs. 20 lakhs for the development of Bodhgaya-Rajgir-Nalanda complex, out of which Rs 13 lakhs have been released for the acquisition of 22 acres of land around the Mahabodhi Temple at Bodhgaya for laying a park. Construction of cafeterias at Rajgir and Nalanda, and a tourist service centre at Bodhgaya are also proposed. In addition it is proposed to construct a Tourist Reception Centre (Motel) at Patna at an estimated cost of Rs. 17 lakhs.

**SHRI DHARAM CHAND JAIN :** May I know whether there is any proposal to have hotels at Patna, Ranchi, Jamshedpur and to develop the one at Netrahat ?

**DR. (SHRIMATI) SAROJINI MAHISHI :** As I have already answered there is a Reception Centre—it is in the form of a motel—which is going to come up in Patna. It may cost about Rs. 17 lakhs. In Netrahat also there is a low-income rest house but in addition to that there may be some expansion within this Plan.

**SHRI DHARAM CHAND JAIN :** What about Jamshedpur ?

**DR. (SHRIMATI) SAROJINI MAHISHI :** There is no proposal for Jamshedpur at present.

**डा० (श्रीमती) सरोजिनी महिषी :** जो माननीय सदस्य कहते हैं सच ही कहते हैं 13 लाख रु० बोधगया के लिए काफी नहीं होते हैं लेकिन 13 लाख रु० वहां की जमीन लेने के लिए हैं न कि वहां की अभिवृद्धि के लिए ही...

**डा० जेड० ए० अहमद :** जमीन इतनी महंगी है ।

**डा० (श्रीमती) सरोजिनी महिषी :** 22 एकड़ जमीन है 13 लाख रु० की, जो ली जा रही है और बौद्ध पर्यटकों की दृष्टि से वैशाली बोधगया, नालंदा और राजगीर, इनके परिवर्धन के लिए सरकार काफी कोशिश कर रही है और जापानी तकनीकियों की मदद भी इसके लिए ले रही है ।

**श्री सीताराम केसरी :** मेरा यह पृच्छना था कि केन्द्र द्वारा शासित करने की कोई योजना है आपकी जिससे कि सेंटर से उसका सीधा सम्पर्क हो ।

**डा० (श्रीमती) सरोजिनी महिषी :** मैंने; जो अभिवृद्धि के संबंध में सारी बातें बताई, वह सब केन्द्रीय सरकार के जरिए ही है ।

**SHRI R. K. PODDAR :** How many sanctions have been given by the Hotel Development Fund in Patna ? When was it done and what is stopping the development in Patna itself ?

**DR. (SHRIMATI) SAROJINI MAHISHI :** By this question the member Means perhaps the loan that has been sought by the different concerns in Patna.

**SHRI R. K. PODDAR :** Not only sought but already sanctioned.

**DR. (SHRIMATI) SAROJINI MAHISHI :** Sanction is the next step.

**SHRI R. K. PODDAR :** How many have already been sanctioned ?

**DR. (SHRIMATI) SAROJINI MAHISHI :** There are three concerns from Patna—  
The L. P. Project Limited, the Hotel Patliputra

and the Bihar Hoteliers Limited. The L. P. Project has sought Rs. 45 lakhs from the Hotel Development Fund, the Hotel Patliputra has sought Rs 24.50 lakhs and the Bihar Hoteliers Rs. 42.50 lakhs but all of them, because they have not got lands and also have not been able to fulfil the necessary formalities which were asked for, the loan has not been sanctioned.

**SHRI BHUPESH GUPTA :** It is very relevant question. Who owns the land ?

**DR. (SHRIMATI) SAROJINI MAHISHI :** That part of the land belongs to the Trust but then part of the land was illegally or unauthorisedly occupied. For removal of this 22 acres had to be acquired.
