(a) whether separate water-meters for each flat in the Multi-storeyed Buildings in Sector XIII R. K. Puram, have since been installed; and

(b) if not, the reasons for delay and when separate water-meters are likely to be installed ?

THE MINISTER OF STATE IN THE MINISTRY OF WORKS AND HOUSING (SHRI I. K. GUJRAL) : (a) No, Sir.

(b) The estimate for the work is under consideration and the work when sanctioned will be taken up on a priority basis.

#### CONSTRUCTION OF COMMUNITY THEATRE HALLS IN DELHI

883. SHRI HABIB TANVIR: Will the Minister of WORKS AND HOUSING be pleased to state :

(a) whether there is a proposal under Government's consideration to construct community theatre halls in various parts of Delhi to provide suitable premises at low

rents for the purpose of rehearsals of plays of major theatre groups of Delhi; and

(b) if not, the reasons thereof?

THE MINISTER OF STATE IN THE MINISTRY OF WORKS AND HOUSING (SHRI I. K. GUJRAL): (a) »nd (b) No, Sir. The Mintstry of Works and Housing have not received any request for construction of community theatre halls in Delhi.

#### SCRIPT FOR PUBLICATION OF BOOKS IN SINDHI

884. SHRI JAIRAMDAS DAULATRAM : Will the Minister of EDUCATION be pleased to state :

(a) whether at the Conference called by the Government of India in March 1970 with a view to setting up a Board for the production of books in Sindhi in the Scheme of rupees one crore for each language it was suggested that the books should be produced in both Devanagari and Arabic scripts;

(b) whether his Ministry consulted the Ministry of Law whether there was any legal objection to the books being published in Devanagari script under the above scheme; and if so, what is the opinion of that Ministry on this point; and

(c) the steps being taken to implement the scheme for Sindhi language?

THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION AND SOCIAL WELFARE (SHRI D. P. YADAV) : (a) The Hon'ble Member had also attended this Conference and he himself had suggested that the Sindhi Books may be published in both and Arabic script.

(b) The Ministry of Law advised :

"There appears to be no legal objection to certain selected work s

being produced in Sindhi language in Devanagari script. Every author seems to have a right to publish his book in any script he likes. The only constitutional prohibition appears to be to impose on a section of citizens a script different from the one they have the right to conserve under Article 29(1)".

(c) The Government are convening a Conference of Sin^bi educationists and writers with a view to obtaining their advice regarding the production of university level books in sirdhi.
