(d) No, Sir. The Gajendragadkar Committee has, however, in its Report on Governance of Universities and Colleges made recommendations regarding reorganisation of powers and functions of the Faculties of Universities. Copies of the Report are available in the Parliament Library. The recommendations made by the Committee have been accepted in principle by the University Grants Commission and the Central Government.

FORMATION OF GENERAL COUNCIL. FOR LALIT KALA AKADEMI

876. SHRI HABIB TANVIR. Will the Minister of EDUCATION AND SOCIAL WELFARE be pleased to state:

- (a) whether it is a fact that Lalit Kala Akademi has been allowed to go ahead with the formation of the New General Council; without waiting for the Khosla Commission Report; and
- (b) if so, whether the draft of the new constitution prepared by the 13-men Committee elected by the All India Conference of artists, art critics and historians convened by the Chirman of the Akademi last year and submitted to the Khosla Commission is being taken into consideration?

THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION, SOCIAL WELFARE AND CULTURE (SHRI D. P. YADAV): (a) No, Sir.

(b) The report of the Khosla Committee is awaited. The question of any consideration by Government would arise only after the report is submitted.

SCALES OF PAY RECOMMENDED BY
ALL INDIA COUNCIL OF TECHNICAL
EDUCATION

877. SHRI PAPI REDDI: Will the Minister of EDUCATION AND SOCIAL WELFARE be pleased to state:

- (a) whether it is a fact that Government propose to revise the pay scales of the employees of the All India Council for Technical Education (AICTE); if so the details thereof;
- (b) the number of times the AICTE scales of pay have been revised so far, since they were introduced in 1960;
- (c) whether Government bear the additional expenditure due to the revision of AICTE scales of pay from time to time;
- (d) if so, what are the amounts granted to various States therefore; and when;
- (e) whether Government have any arrangement to ensure that the various States introduced the scales of pay recommended by the All India Council of Technical Education; and
- (f) when the latest revision of AICTE scales of pay will be implemented?

THE MINISTER OF EDUCATION AND SOCIAL WELFARE (PROF. S. NURUL HASAN). (a) to(c) No, Sir. There are no employees of the All India Council for Technical Education. The All India Council is an advisory body set up by the Central Government for the coordinated development of technical education and maintenance of its quality and standards. The Ministery of Education acts as the Secretariat of the All India Concil.

To solve the problem of acute shortage of teachers in technical institutions, the All India Council recommended and the Cenral Government accepted in 1959 a scheme to revise the pay scales of teachers of technical institutions. The Central Government also agree to bear 100 per cent of the additional expenditure involved in the revision of pay scales for a period of five years in the first instance. This period was later extended upto 31.3.1969. The State Governments have since then been bearing the entire additional expenditure.

The revised pay scales as approved by the Central Government and suggested to the State Governments in 1969 are as given in Annexure I.

Written Answers

- (d) A stetement showing the amounts of grants sanctioned by the Central Government to defferent States for the implementation of the revised pay scales is given at Annexure II.
- (e) The Central Government cou d only offer assistance to the States for the revision of pay scales in their respective

institutions. The grants have been sanctioned on the basis of the actual expenditure incurred by the States for the revision of pay scales.

(f) The question of further revision of the pay scales of teachers of technical institutions was considered by the All India Council for Technical Education at its meeting held on 22nd April, 1972. The All India Council decided that this matter should be examined further after the report of the Third Pay Commission was available.

- (a) whether it is a fact that in the Universities in foreign countries Operational Research in Post Graduate Classes is taught as an independent subject, like Mathematics, Physics etc;
- (b) the fields in which this subject is put to maximum use in India;
- (c) whether it is a fact that Operational Research is taught in Post-graduate Classes and an independent subject only in Delhi University:

- (d) if so, the reasons for which this subject is not taught in other Universities and Constituent Colleges of Deihi University; and
- (e) the steps proposed to be taken by U. G. C. to make the subject as an independent one in all the Universities?

THE MINISTER OF EDUCATION. SOCIAL WELFARE AND CULTURE (PROF. S. NARUL HASAN): (a) Precise information is not available. It is, however, understood that Courses in Operational Research are provided in some universities as part of the course for Master's degree in Mathematics.

- (b) Concept and Techniques of Operational Research are useful in the fields of industrial as well as applied research generally.
- (c) According to the available infor mation the Operational Research is taught in the Post-graduate Classes as a full Course in the University of Delhi only. The University has also taken steps to introduce Operational Research as a paper for B.A./B Sc (Hons.) degree in Mathematics.
- (d) it is for the University concerned to decide about the introduction of various courses at the Graduate & Postgraduate level.
- (e) The University Grants Commission has set up an Expert Panel on physical Sciences. The question of suggesting to the Universities to provide full M.Sc. course in operational Research will be examined by the Panel.
