## Spreading of Gastro-Enteritis Disease in Kerala

581, SHR1 K. CHANDRASEKHARAN: Will the Minister of HEALIH AND FAMILY PLANNING be pleased to state:

- (a) Whether Gastro Enteritis is spreading in Cannanore District of Kerala State, and has also become acute in Kasaragod Town;
- (b) whether the disease is caused due to consumption of the low quality rice and other adulterated foodstuffs;

(c) to what extent has the disease affected the people of Cannanore District;

to Questions

(d) what steps are being taken by Government to check and control the disease?

THE MINISTER OF STATE FOR HEALTH AND FAMILY PLANNING (PROF. D. P. CHATTOPADHYAYA):
(a) Outbreak of gastro-enteritis had been reported from Cannanore District of Kerala State since 21st January, 1972 but the incidence is now reported to be under control. A few cases were reported from Kasargod since 29th February, 1972.

- (b) The disease does not appear to be related to the quality of ration rice or adulteration of foodstuffs. This has presumably been due to water borne ineffective organism.
- (c) 2082 cases were admitted in various hospitals in Cannanore District duging the period from 21st January to 13th March, 1972. Out of these cases, 1953 were cured and 28 died in hospitals including two at Kasargod. There were also out-patients in many of the hospitals.
- (d) Necessary preventive and curative measures against the spread of disease have been taken by the State Health authorities. These include adequate provision of essential drugs and disinfectants, disinfection of water supplies and infected houses, and anti-cholera mass innoculations.

THE DEPUTY MINISTER IN THE MINISTRY OF **EDUCATION** AND SOCIAL WELFARE (SHRI D.P. YADAV): (a) Yes, Sir.

(b) & (c). The scheme formulated by Government of India in 1971-72 for providing employment to the educated unemployed will continue to operate during the remaining part of Fourth Five Year Plan. Under that scheme Central assistance has been provided to the States and Union Territories for appointing 30,000 primary school teachers, 240 assistant inspectors of schools and 1000 instructors of 'Work experience' distribution of free text books and stationery to about 9 lakh children, supply of midday meals to about 8.6 lakh additional children. The scheme includes construction of rooms, worksheds, purchase of equipment etc. An amount of Rs. 4,416 crores was provided for this scheme for a period of four months during 1971-72. The above scheme will be continued in 1972-73 and the anticipated outlay during the full year is Rs. 12 crores. An additional allocation of Rs. 18 crores is being provided in 1972-73 for further expansion of the programme.
