THE MINISTER OF DEFENCE (SHRI JAGJIVAN RAM): (a) No, Sir. Soviet technical advice has, however, been obtained in connection with works taken up in the development of Naval repair facilities at Visakhapatnam. The development of port facilities in Andaman & Nicobar Islands is being made solely by Indian technicians.

- (b) Specialist advice is being sought by our personnel only when it is inescapable.
- (c) Does not arise as no works are being handled by Soviet technicians.

### AID BY WORLD BANK

- \*512. SHR1MATI PRATIBHA SINGH: Will the Minister of FINANCE be pleased to refer to Starred Question No. 4 given in the Rajya Sabha on the 14th March, 1972 and state:
- (a) the extent to which the World Bank has agreed to help India to meet the additional burden caused on India's economy by the Bangla Desh refugees and other allied problems;
- (b) how much of this aid to be in the shape of (i) grants, and (ii) interest free loans; and
- (c) how much of the total World Bank aid would be untied?

THE MINISTER OF FINANCE (SHRI Y.B. CHAVAN): (a) No separate assistance has been given by the World Bank or IDA to meet the additional burden caused by the Bangla Desh refugees and other allied problems. However, in the context of the additional burden caused on India's economy by the Bangla Desh refugees the World Bank arranged for the preparation of a report assessing the cost of refugee relief, which was considered by a special meeting of the members of the India Consortium in This meeting recognised October 1971. that refugee relief was an international responsibility and several members indicated their willingness to provide substantial eontributions towards the cost of refugee relief.

(मध्य प्रदेश कम्पोजिट टेक्नीकल) रेजीमेंट एन० सी० सी० भोपाल के साथ मिला दिया गया था। 1971-72 में संस्थान केवल 82 कैंडेट देने में समर्थ हो सका है तथा संस्थान में एक स्वतंत्र कम्पनी 200 कैंडटों की चलाने के लिए पर्याप्त कैंडेट नहीं हैं। ग्रन्य स्थानों में भी इसी प्रकार की व्यवस्था है।

टैक्नीकल यूनिट जो गवर्नमेंट इन्जीनियरिंग कालेज, रीवां स्थित है, 7 मध्य प्रदेश इन्जीनियर एन० सी० सी० कम्पनी हैं। 70-71 तक यह ग्रपनी 200 कैंडेटों के प्राधिकृति संख्या शक्ति कम से कम 50 प्रतिशत देने में समर्थ था और इसीलिए इसे स्वतंत्र कम्पनी के रूप में कार्य करते रहने की ग्रनुमति दी गई थी। तथापि 1971-72 में इसकी कैंडेट संख्या शक्ति 50 प्रतिशत से कुछ कम हो गई थी तथा यह प्रश्न कि क्या इस यूनिट को एक स्वतंत्र कम्पनी के रूप में कार्य चालू रखने दिया जाय विचाराधीन है।

#### STATEMENT

There is no discrimination in the matter of NCC training and the training syllabus laid down for various types of units is nniform throughout the country. However, actual composition and structure of units vary from one location to another and this is dependent upon the number of eligible students who volunteer for enrolment and the financial and administrative cover which the institutions and the State Government are in a position to provide.

The Composite Technical Regiment, a two company unit, located at Samrat Ashok Technological Institute, Vidisha (No. 2 Madhya Pradesh Composite Technical Regiment NCC) had to be disbanded in 1969 as sufficient number of cadets did not enrol and the State Government did not consider it necessary to allow the unit to function

separately. With a view to ensuring the NCC training facilities are not completely withdrawn, this unit has been amalgamated with 1 Madhya Pradesh Composite (Tech) Regiment NCC Bhopal in August 1969 on the recommendation of the Government of Madhya Pradesh. The institution has been able to provide 82 cadets only in 1971-72 and the intake at the institution is not sufficient to maintain an independent company of 200 cadets. Similar arrangements exist at other places also.

The Technical Unit located at the Government Engineering College, Rewa, is 7 Madhya Pradesh Engineer Company NCCs. Upto 1970-71 it has been able to provide at least 50% of its authorised strength of 200 cadets and as such it has been allowed to continue as an independent Company. In 1971-72, however, the cadet strength is slightly less than 50% and the question whether this unit should be continued as an independent Company is under consideration.
