THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY PLANNING (DR DEBI PRASAD CHATTOPADHYAYA) : (a) To accelerate the Rural Water Supply Programme and to provide employment opportunities to the educated unemployed the Central Government sanctioned in December, 1971, a new scheme of Planning and Design Units for Rural Water Supply with 100 per cent central assistance to prepare detailed estimates and plans for execution of piped water supply schemes in difficult and scarcity areas which have already been investigated by the Special Investigation Divisions for Rural Water Supply

(b) Central assistance will be given to all the State Governments and the Union Territory of Arunachal Pradesh to implement this scheme

(c) The Financial liability for this scheme during the Fourth Plan will be of the order of Rs 110 00 lakhs
