SIDDHESHWAR PRASAD): (a) and (b) Tenders were invited for the award of the contract twice in 1965 and the contract was entrusted to Handling Porters' Co-operative Society Ltd., keeping in view the declared policy of the Government to encourage co-operative effort and also the fact that the Society was experienced in the line. Taking into consideration the satisfactory performance of the Co-operative Society, the period of the contract was extended from time to time without calling for tenders and the last extension was given for two years with effect from 5-1-1971.
