

**GOVERNOR'S STATEMENT ON OVER-DRAFT BY
MYSORE GOVERNMENT**

♦559. SHRI PRANAB KUMAR MUKHERJEE : WUI the MINISTER OF HOME AFFAIRS be pleased to state :

(a) whether Government have ascertained the circumstances in which Shri Dharma Vira, ex-Governor of Mysore, made some statements about the repayment of overdrafts from the Reserve Bank of India by the State Government of Mysore ;

(b) if so, what were these circumstances ; and

(c) what action Government propose to take to prevent such statements in future ?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI K. C. PANT) : (a) and (b) Shri Dharma Vira met the President and later also wrote to him in this connection. In the light of the position explained by Shri Dharma Vira, it was not considered necessary to pursue the matter.

(c) No specific action is necessary in this behalf.

SHRI PRANAB KUMAR MUKHERJEE : May I know from the Minister whether it is a fact that Shri Dharma Vira, when he was the Governor of Mysore when that State was under President rule, pointed out categorically that Mysore State would not pay the over-draft drawn from the Reserve Bank until and unless the Government of India is going to meet their requirements as demanded by the State ? If so, can any Governor while carrying out the business as the agent of the President of India say such things and if he says such things, does the Government of India desire to continue such a state of affairs as if as the head of an independent State he can issue warnings to the Central Government challenging their authority ?

SHRI K. G. PANT : So far as the general question is concerned, it is not right for any Governor to hold out any threat either to the Reserve Bank of India or to the Central Government. There can be no dispute on that and there can be no two opinions about that. But, so far as Shri Dharma Vira's state, ment goes, there was a news report dated the 17th January in "The Hindu" in which it was stated that he had said something to the

effect that the Mysore Government would not repay the overdrafts if the Government did not give special accommodation to cover both the Plan and the non-Plan gaps. But, later on, on the 30th January, according to "The Hindustan Times" Shri Dharma Vira denied this statement. He denied that he had ever said like this. I am quoting from the paper :

"He denied that he has ever said that the State would refuse to pay the overdrafts to the Reserve Bank if the assured special assistance to the State Plan was not forthcoming."

MR. CHAIRMAN : Yes, Dr. Alva.

DR. K. NAGAPPA ALVA : May I know, Sir, from the Minister whether it is not a fact that there was a commitment by the Planning Commission as well as the Central Government to make an accommodation to the tune of Rs. 105 crores to the Mysore Government ?

SHRI K. C. PANT : Sir, this is really a question which the Finance Ministry can answer better and I would request my hon. friend to direct this to the Finance Ministry.

MR. CHAIRMAN : Yes, Dr. Mahavir... Are you putting your question or not ?

DR. BHAI MAHAVIR : Yes, Sir, I am putting my question, Does the Government accept this or not that the statement of the ex-Governor of Mysore points to the difficulty experienced by the various States due to the imbalance between their responsibilities and their resources as the present arrangement exists and due to the lack of adjustment between the role of the Finance Commission and that of the Planning Commission and, if so, may I know whether that question will be taken up by the Government for the proper settlement ?

SHRI K. C. PANT : Sir, again this is n-ally for the Ministry of Finance to answer.

MR. CHAIRMAN : Yes, I think so. Yes, Mr. Advani.

SHRI LAL K. ADVANI : Sir, is it a fact that at an earlier stage it was tentatively decided to send Mr. Dharma Vira as the Ambassador to Bangla Desh and because of his statement, even though the Government says that no action has been taken, this decision was not taken ?

SHRI K. C. PANT : I am not aware of this, Sir.

MR. CHAIRMAN : Yes, the next question.

found against the Navbharat Enterprises during the
course of the said enquiry ; and

(d) if so, what action has been taken in the
matter ?]

गृह मंत्रालय और कार्मिक विभाग में
राज्य मंत्री (श्री राम निवास मिर्धा) : (क)
से (ग) केन्द्रीय जांच ब्यूरो द्वारा नेशनल फेड-
रेशन आफ इंडियन विमेन या नवभारत एंटर-
प्राइजेज के मामलों के सम्बन्ध में कोई जांच

नहीं की गई थी। तथापि, औद्योगिक विकास
मंत्रालय के एक अधिकारी के विरुद्ध एक मामले
की जांच-पड़ताल के दौरान, यह पता करने के
लिए जांच की गई थी कि क्या नेशनल फेड-
रेशन आफ इंडियन विमेन द्वारा प्रकाशित
विवरणिका के लिये विज्ञापन प्राप्त करने में
उक्त अधिकारी ने अपने सरकारी प्रभाव का
प्रयोग किया था। जिन फर्मों ने विवरणिका
में विज्ञापन दिये थे उनमें से एक नवभारत एंटर-
प्राइजेज था।
