and existing arrangements strengthened at a large number of places in the country.

- (c) No, Sir. These places have not been included due to other priorities.
- (d) Extensive publicity is being mounted both in India and abroad through our Tourist Offices and other Embassies, sources.7

INCREASE IN BAD DUBTS OF STATE BANK OF INDIA

- \*19 CHANDRA-SHRI K. SEKHARAN: Will the Minister of FINANCE be pleased to state:
- (a) whether the bad debts of the State Bank of India and its subsidiaries registered a marked increase during the last two years;
- (b) whether there has been an increase of loans in default so far as repayment is concerned: and
- (c) the steps Government propose to take in the matter of speedy realisation of loan instalments overdue?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI K. R. GANESH): (a) and (b) debt is considered bad when all possible methods of recovery prove to be ineffective and that portion of the debt not realisable is actually written off every year, Adequate provision for bad and doubtful debts is also made every year in consultation with the statutory auditors before finalising the accounts of the year and amounts written off are adjusted against the provision. Taking into account the volume and nature of business in the past few years by the large number of offices of the State Bank of India and its subsidiaries there is no reason to believe that either the bad debts or the loans in default are showing any marked tendency to increase in the last two years.

(c) For recovery of loan instalments overdue, a system of close follow-up includ-

ing resort to legal action, wherever necessary, is continuously in vogue in each of the banks.
