FIRST PHASE OF WATER SUPPLY SCHEHE IN RANIGANJ COAL-FIELD AREA

- 49. SHRI KALYAN ROY: Will the Minister of HEALTH AND FAMILY PLANNING be pleased to refer to the reply to the Unstarred Question Nos. 123 and 545 given in the Rajya Sabha on the 21st July 1971 and 24.11.71, respectively and state:
- (a) whether the first phase of the Scheme for supply of drinking water in coalfield areas in Raniganj-Asansol has since been completed;
- (b) if not, the reasons thereof and approximate lime within which it will be completed;and
- (c) whether Government would hold an impartial enquiry to ascertain the real causes of this delay in completing the Scheme and if not, the reasons thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND FAMILY PLANNING (SHRI A. K. K.ISKU): (a) to (c) The Raniganj Coal Field Area Water Supply Scheme is' a State Scheme and the information is awaited from the State Government. It will be laid on the Table of the Sabha on receipt.

IMPORT OF FERTILISER

- 50. SHRI BABUBHAI M. CH1NAI: Will the Minister of AGRICULTURE be pleased to state:
- (a) whether it is a fact that Government is considering a proposal to reduce the amount incurred on the import of fertilizer; and
- (b) if so, what is the amount spent on the imports of fertilizers during the last one year and what is the extent of the cut proposed I

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ANNASAHEB SH1NDE): (a) and (b) In view of its critical importance in agricultural development, Government imports fertilisers to the extent the requirements of farmers cannot be met through indigenous production. The actual quantity of fertilisers thus imported depends upon the stocks on hand, the estimated

requirements ;md the estimated domestic production. Government does not propose to reduce the import of fertilisers to the detriment of agricultural production.

In the year 1970-71, the imports of fertilisers were 4.77 lakh tonnes of N, O. 32 lakh tonnes of P205 and 1.08 lakh tonnes of K20 valued at Rs. 75.90 crores on cost-cum-freigh basis. In 1971-72 the imports are expected to be larger — 4.80 lakh tonnes of N, 2.30 lakh tonnes of P205 and 2.80lakh tonnes of K20at an estimated cost of Rs. 95.87 crores on cost-cum-freight basis. The increased import in 1971-72 was called for due to increased consumption of fertilisers envisaged in 1971-72.

SECOND PHASE OF WATER SUPPLY SCHEME IN RANIGANJ COALFIELD ARIA

- 51. SHRI KALYAN ROY: Will the Minister of HEALTH AND FAMILY PLANNING be pleased to refer to the answer to Unstarred Question No. 545 given in Rajya Sabha on the 24th November, 1971, and state;
- (a) whether the Government of West Bengal has approached the Central Govern ment for funds to start the second phase of the Raniganj Coalfield Areas Water Supply Scheme:
 - (b) if so, the amount needed for the Scheme;
- (c) whether the funds have been sanctioned by the Union Government; and
 - (d) if not, the reasons thereof '.'

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND FAMILY PLANNING (SHRI A. K. K1SKU): (a) Yes, The Government of West Bengal had requested the Central Government for special assistance outside the State Plan for the execution of the second phase of the scheme.

- (b) The second phase of the Scheme is estimated to cost Rs. 3.28 crores.
- (c) and (d) No special assistance is pro posed to be given to the State Government for this scheme as Central assistance to the State: is now being given in the form of block loans and block grants without reference to any particular scheme. It is for the State Government to find funds for the scheme from within their overall plan resources.
