If the presumption is correct, it may be stated that Government have not undertaken any general study of the type referred to.

# ATOMIC ENERGY STATION IN ANDHRA PRADESH

THE PRIME MINISTER AND THE MINISTER OF ATOMIC ENERGY (SHRI-MATI INDIRA GANDHI): (a) and (b) A Site Selection Committee has been appointed by the Government to select suitable sites for atomic power stations in the Northern, Western and Southern Electricity Regions. The investigation of sites in the Suothern Electricity Region including Andhra Pradesh is in progress. A decision regarding setting up a nuclear power station in Andhra Pradesh will be taken in the light of the recommendations of the Site Selection Committee.
