**MANUFACTURE OF HEXAMINE AND FORMALDEHYDE**

\*77. SHRI ARJUN ARORA: Will the Minister of INDUSTRIAL DEVELOPMENT be pleased to state:

(a) whether the Atul Drug House Ltd., has been issued a letter of intent permitting a substantial expansion for the manufacture of Hexamine and Formaldehyde;

(b) if so, whether as pre-condition the above firm has been asked to reduce the foreign holding in equity capital to 49 per cent;

(c) whether the above condition has been complied with; and

(d) if not, the reasons therefor?

THE MINISTER OF INDUSTRIAL DEVELOPMENT (SHRI MOINUL HAQUE CHOUDHURY): (a) to (d) A letter of intent had been issued to M/s. Atul Drug House Ltd. for regularisation of the expansion achieved in the manufacturing capacity of Formaldehyde and Hexamine at the Vapi plant. A reduction in the foreign equity has been imposed as a condition for conversion of the letter into an industrial licence. The firm has contended that in regard to the specific proposal no fresh issue of capital was necessary and, hence, in connection with this scheme the foreign equity could not be reduced to a lower figure. The letter of intent has not so far been converted into an industrial licence and the case is under examination.

**ACTIVITIES OF CIA IN INDIA**

\*78. SHRI K. P. SUBRAMANIA MEENON: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether the attention of the Government of India has been drawn to a recent despatch in "Washington Evening Star" from its New Delhi correspondent Mrs. Henry Bradsher to the effect that the CIA had a vast intelligence net work in India;

(c) whether Government have taken any steps to stop the activities of the CIA in India; and

(d) the steps taken by Government in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI K. C. PANT): (a) No, Sir. Government have, however, seen a report in the Indian Express dated 20th January, 1972, which refers to the despatch of Mr. Henry Bradsher, published in the 'Washington Evening Star.'

(b) to (d) Government certainly keeps a watch on the activities of foreign intelligence organisations, including the CIA. Government has also made it known that such activities are not conducive to the promotion of good relations with our country. However, Hon'ble Members will appreciate that no public interest would be served by Government disclosing the details of what it does to counter such activities.
