During the period from the 25th March, 1971, to the 2nd December, 1971, the number of persons arrested in connection with cases of sabotage or on suspicion of being saboteurs was 24 in West Bengal, 73 in Assam and Maghalaya, 26 in Tripura and nil in other States. The cases against the arrested persons are being investigated according to law and the question of their deportation will arise only after all action against them under the law is completed.

(c) Four persons have been arrested in Uttar Pradesh, District Bareilly, for providing assistance to a Pakistani prisonerof war to make good his escape from custody. A case against them is being investigated according to law.]

†(THE MINISTER OF INDUSTRIAL DEVELOPMENT (SHRI MOINUL HAQUE CHOUDHURY): During the calendar years 1969, 1970 and 1971, 224, 438 and 1015 letters of intent respectively were issued. Investment data in respect of letters of intent issued from 1-4-70 onward only is available. Out of the 438 letters of intent issued during 1970, investment data in respect of 316 letters of intent is available. It is observed that out of the 316 letters of intent in respect of which data is available 299 letters of intent are those in which

an investment on fixed assets i.e. land, building and machinery of more than Rs. 10 lakbs is involved. Similarly out of the 1015 letters of intent issued in 1971, data in respect of 935 letters of intent is available. It is observed that there are 867 letters of intent in which an investment on fixed assets i.e. land, building and machinery of more than Rs. 10 lakhsis involved. Details of all licences and letters of intent issued including the industry to which they relate. are regularly published in the Weekly 'Bulletin of Industrial Licences, Import Licences and Export licences,' the Weekly 'Indian Trade Journal' and the monthly 'Journal of Industry and Trade.'
