DECLINE IN INDUSTRIAL OUTPUT

- 85. SHRI KALYAN ROY: Will the Minister of INDUSTRIAL DEVELOPMENT be pleased to state:
- (a) whether it is a fact that the industrial output sharply declined in the year 1971-72 as compared to the years 1968-69 and 1970-71;
  - (b) if so, the reasons therefor; and
- (c) the steps Government have taken or propose to take to utilise the unutilised capacity of the industry and open the closed industrial units?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRIAL DEVELOP-MENT (SHRI GHANSHYAM OZA): (a) to (c) A statement is attached.

## STATEMENT

- (a) to (c) Provisional figures of industrial production are available only upto the calendar year 1971. A number of factors have combined to decelerate the overall rate of growth of industrial production during 1971. factors are briefly indicated below:
- (a) Some industries have been affected by capacity constraints so that their overall growth rate has come down.
- (b) Some industries have been affected by sluggish demand.
- (c) There have been production problems, including problems of labour--management relations, in a number of industries.

(d) Occasional break downs of power, and transport difficulties in the Eastern Region (arising from the need to give priority to the movement of refugees, etc), have affected production in a number of industries.

to Questions

- (e) Shortage of raw materials (like sugar cane, raw cotton and steel) has affected production in a number of industries.
- 2. Some of the measures adopted by Government to accelerate production to reach the plan target of 8 to 10 per cent growth rate are as follows:
  - (i) Industrial Licensing Policy has been significantly liberalised to ensure a fuller utilisation of installed capacity in various industries:
  - (ii) Industrial licensing procedures have been streamlined and the pace of licensing has been accelerated;
  - (iii) The value of import licensing of Capital Goo's has also been increased con: iderably; and
- (iv) Licensing of the import of steel has been stepped up. During 1971-72 import licensine of other critical raw materials has also been increased.
