EXPORTABLE GOODS OF BANGLA DESH

- (a) whether exportable stocks of goods including newsprint, spices and dried fish, worth between Ks. 20 crores to Rs. 40 crores have been located at various places in Bangla Desh; and

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH): (a) It is understood that exportable stocks of goods, including newsprint, spices and dried fish, are available in Bangla Desh but the exact value of the stocks is not known.

(b) The matter is under discussion with the Bangla Desh authorities.

FINANCIAL LOSS OF HINDUSTAN STEEL LTD.

STATEMENT

(a) and (b) The working results of Hindustan Steel Limited for the financial year 1971-72 would become known only after the accounts for the year have been closed and audited. The indications, however, are that the Company would sustain a substantial loss this year. This is primarily due, to shortfalls in production resulting from the collapse of the roof of (he Steel Melting Shop of Rourkela Steel Plant
