(a) and (b) The working results of Hindustan Steel Limited for the financial year 1971-72 would become known only after the accounts for the year have been closed and audited. The indications, however, are that the Company would sustain a substantial loss this year. This is primarily due, to shortfalls in production resulting from the collapse of the 100f of the Steel Melting Shop of Routkela Steel Plant
