Madhya Pradesh had proposed 75 tribal development blocks in addition to blocks already existing, and out of these, ten blocks were sanctioned during the year 1966-67;

- (b) whether it is also a fact that later on this allotment was cancelled and Government of India decided that no more blocks would be opened during the Fourth Plan period;
- (c) whether in view of the special responsibilities on them in upliftment of tribals and tribal areas the Government of India propose to re-consider this policy and sanction the 76 additional blocks; and
  - (d) if not, the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION AND SOCIAL WELFARE (SHRI K. S. RAMASWAMY): (a) Yes, Sir.

(b) to (d) With the commencement of the Fourth Plan in 1969-70, it was decided that the available resources during the Fourth Five Year Plan should be utilised in the existing T. D. Blocks by extending the total life from 10 years to 15 years by incorporating a new stage III with an additional allotment of Rs. 10 lakhs per block. In view of the creation of stage III of T.D. Blocks, it was decided that no new T.D. Blocks would be opened during the Fourth Plan period.

#### RECRUITMENT OF SEAMEN

- 308 SHRI KALYAN ROY: Will the Minister of PARLIAMENTARY AFFAIRS AND SHIPPING AND TRANS-PORT be pleased to state
- (a) whether Government's attention has been drawn to the reported demostration of Indian seamen at Calcutta against the recruitment of fewer seamen for the latest vessel of Messrs India Steamship Co Ltd,
  - (b) If so, the details thereof, and
- (c) whether the Manning scale rules for the seamen under the Merchant Shipping Act, 1958, has been introduced, and if not, the reasons thereof?

THE MINISTER OF PARLIAMENTARY AFFAIRS, AND SHIPPING AND TRANSPORT (SHRI RAJ BAHADUR). (a) and (b) There was no demonstration of Indian Seamen at Calcutta. Only four seamen out of forty two seamen called for signing on 'Indian Venture' in January 1972 had raised individual objection to lesser complement being signed on the above vessel. The position was satisfactorily explained to the crew members and all the forty two seamen were signed on the ship.

(c) The manning scale for the seamen for different classes of ships, under the Merchant Shipping Act, 1958 has not so far been prescribed. The reason is that the manning scale is fixed by bilateral negotiation between shipowners, and the recognised
