#### REVIEW OF THE INDO-U. S. RELATIONS

Will the Minister of EXTERNAL AFFAIRS be pleased to state :

(a) whether Government have undertaken any comprehensive review of the whole gamut of Indo-U. S. relations in the context of the openly anti-Indian attitude adopted by American Government in recent months especially during the Indo-Pakistan conflict ; and

(b) if so, what practical changes are being adopted in its relations towards U. S. A. to meet the new situation ?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH) : (a) Yes, Sir.

(b) It is not customary to reveal such matters in advance.

#### PAK MOVE FOR U. N. OBSERVERS ON BORDER

351. SHRI M. V. BHADRAM : Will the Minister of EXTERNAL AFFAIRS be pleased to state :

(a) whether Government are aware of the Pak move to set U. N. Observers posted on the Western border in the name of preventing alleged truce violations by India ; and

(b) if so, what is Government's reaction to the Pak move ?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH) : (a) Yes, Sir. On January 24, 1972 Pakistan asked for an urgent meeting of the Security Council to consider the situation caused by alleged violations of the cease-fire between India and Pakistan and "the consequent necessity of stationing U. N. observers" on the border of India and Pakistan.

(b) The Members of the Security Council held informal consultations on the Pakistani request. There was general consensus not to take up matters raised by Pakistan for the present. The Permanent Representative of India, during the informal consultations, explained Government's view that there was no need for any U. N. machinery for observance of the cease-fire on the Indo-Pakistan border, as the situation was relatively quiet.
