having its own special features. The Penta-conta system of exchanges which was imported is one of them and is known as Crossbar system all over the World.

(b) if so, the tctal number of hippies and the foreign disciples of Indian Sadhus who are now in India; and

(c) what kind of check is kept on their movement inside the country ?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F. H. MOHSIN) : (a) and (b) No separate statistics of hippies and followers of Indian Sadhus coming from foreign countries is maintained.

(c) Vigilance is maintained and suitable action under the appropriate laws is taken whenever there are signs of undesirable activities on the part of such foreigners.

SUBVERSIVE ACTIVITIES IN KASHMIR

489. SHRI VENIGALLA SATYA NARAYA-NA: Will the Minister of HOME AFFAIRS be pleased to state :

(a) whether Government have unearthed a gang of persons engaged in subversive activities in Kashmir; and

(b) if so, the details thereof?

THE PRIME MINISTER AND THE MINISTER OF HOME AFFAIRS (SHRIMATI INDIRA GANDHI): (a) and (b) According to the information supplied by the Government of Jammu and Kashmir certain individuals involved in subversive activities have been arrested and action is being taken against them under the law.

PER CAPITA INCOME

490. SHRI SUNDAR SINGH BHANDARI: Will the PRIME MINISTER be pleased to state the per capita income of each State and the country as a whole during the last three years as also at the beginning and end of each of the three Plan periods ?

THE PRIME MINISTER (SHRIMATI INDIRA GANDHI) : The available estimates of per capita income of various States, prepared by the respective Slate Statistical Bureaux, and the estimates of per capita national income for the country, prepared by the Central Statistical Organisation, are given in the attached statements *[See* Appendix LXXIX, Annexure Nos. 31 and 32.] Owing to differences in concepts, source materials used, methodology and the base years, the per capita income estimates of States are not comparable among the States or with the estimate for all-India.
