SHRI BHUPESH GUPTA (West Bengal)
Madam I have a suggestion to make. Since you are in the Chair, it has to be decided by the Chairman of the House. We are facing some difficulties now. Reports of Public Accounts Committee are placed here. But in the Committee no note of dissent is allowed. In the Public Undertakings Committee also no note of dissent is allowed. Now the situation is becoming complicated. Some Members on the Public Accounts Committee like some of us who are there, sometimes differ from some of the comments. But they are not in a position to give a note of dissent. This is happening in the public Accounts Committee where preposterous decisions are being taken by majority. I can speak for my Party members who are in a minority that they are not in a position to append any note of dissent. I would, therefore, request you that this matter should be considered. The Minister of Parliamentary Affairs should also take note of it. Otherwise it is difficult to function in such committees. The country will not know that we are opposed to some of the decisions and conclusions that are arrived at, unless you allow notes of dissent.
