(PROF. D. P. YADAV): (a) The Kendriya Sachivalaya Hindi Parishad, New Delhi is a Voluntary Hindi Organisation and as intimated by the Parishad, they hold a (competition in Hindi typewriting every year.

(b) In the Competition held by the Parishad in October, 1970 the maximum speed attained on the Hindi typewriter with old key-board was 84.25 per minute and that on the typewriter fitted with key-board approved in 1964 was 56.3 per minute.

(e) No Sir. The speed on a type writer does not entirely depend on any particular model. It is the skill and proficiency of the operator which largely determines the speed.
