

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE/ **विदेश व्यापार मंत्रालय में उपमंत्री** (SHRI A. C. GEORGE) : (a) Import of 'The Complete Works of Shakespeare' was included in the non-permissible list in the import policy for 1971-72 period in view of the availability of reprints in India. The position was reviewed and the import of the 'Complete Works of Shakespeare' was allowed by Public Notice No. 67-ITC(PN)/ 71 dated 24-6-1971.

(b) Import policy is framed by the Chief Controller of Imports and Exports under the general directions of the 'Ministry of Foreign Trade' in consultation with the other authorities concerned, whenever necessary.

(c) A statement showing the imports of books, periodicals and journals during 1968-69, 1969-70 and 1970-71 is placed on the Table of the House. [See Appendix LXXVII, Annexure No. 55]

(a) the steps taken by Government so far in regard to ensuring that incidents of Pakistani firings inside Indian territory resulting in loss of life and property of Indians do not recur and the manner in which the Government of India have protested to the Government of Pakistan in this regard ; and

(b) the extent of losses of property suffered by Indians so far as a result of Pakistani firing inside Indian territory ?

(a) The Border Security Force has been adequately strengthened all along the border with Bangla Desh and have instructions to throw back any intruding army or force from across the border and also to reply effectively to any shelling or firing from the other side. Protests are lodged in all such cases with the Government of Pakistan. Remanding compensation for loss

of life and property, and injury to persons as a result of such incidents.

(b) Damage has been caused to buildings of 3 border out-posts and 1 Railway Station; about 60 huts have been damaged or partially burnt. In addition, 4 houses have been completely burnt; 2 motor launches and two civilian vehicles were damaged; and 4 heads of cattle were killed and 13 heads of cattle injured.

REGULARISATION OF CNAUIHORISED SPINDLES

(c) whether Government have regularised some unauthorised spindles during the past three years; and

(d) if so, the reasons thereof ?

A. C. GEORGE) : (a) No positive information regarding the number of unauthorised spindles which existed in the country before 1970 is available. However, the number of unauthorised spindles which had come to the notice of Government in October, 1970, was about 40,000. It is likely that some more unauthorised spindles then in existence might not have come. In response to a Press Note issued by the Textile Commissioner requests for regularisation of 1,76,865 worsted spindles have been received. It is not proposed to regularise any spindle without proper verification by a team of competent officers.

(b) As per the Press Note, the regularised worsted spindles will not be entitled to a quota of imported raw wool as a matter of right. However Government may allocate to them quota at a reduced scale as compared to the regular spindles.
