State? If so, may I know why the Government did not take steps to prevent it? Do I understand that the Government is absolutely helpless in such matters? Instead of taking action against them, why has the Government come to an agreement virtually with the Birlas, as my friend, Mr. Niren Ghosh, mentioned, by purchasing their Camac Street building at a very inflated price, running into several crores of rupees? The Birlas built this : skyscraper to accommodate all their offices in that building. The decision to shift was taken later. (Interruption) What steps has the Government taken to ensure that the employees are not made unemployed and the offices remain there and anyhow it does not buy that particular building at inflated prices?

SHRI GHANSHYAM OZA: We are not aware of any threats being held out to the Government by the Birlas that if we did not agree to this thing, they will do something else. About the building, as I said to the hon. Member who put the previous question, we are not aware of it and we are not concerned with it. It was not done in any way directly or indirectly.

(Interruptions)

SHRI CHITTA BASU: Is he not representing the Government?

SHRI BHUPESH GUPTA: On a point of order. Sir, this was published in the newspapers and we have raised it in the House. All particulars about this Camac Street building were given here and he says he is not aware of it.

MR. CHAIRMAN: All right; Mr. Mani.

SHRI A. D. MANI: The hon. Minister made a reference to flight of capital. May I ask the Minister whether apart from this question of Birlas shifting their headquarters and maintaining only a skeleton staff in Calcutta, there has been a flight of capital even after....

- (a) The Phase II of the Rajasthan Canal Project has been posed to the World Bank for financial assistance. A reconnaisance Mission of the Bank had visited the Project in the month of March 1971. The broad outlines of the Project have also been discussed with the World Bank in a preliminary way and the matter is under further consideration in the Government of India.
- (b) In addition to the Fourth Plan outlay of Rs. 40 crores for the Rajasthan Canal Project, the following Central assistance has been/1s being given to this project:—

1969-70 ... Rs. 3.2 crores 1971-72 ... Rs. 3.0 crores

Further allocation to Rajasthan Canal would, however, depend on the re-appraisal of the Fourth Plan.
